NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 018-053, LITTLE OYSTER CREEK AND WINDMILL POINT

EFFECTIVE 2 NOVEMBER 2010

Pursuant to Title 28.2, Chapter 8, §§28.2-803 through 28.2-808, §32.1-20, and §2.2-4002, B.16 of the Code of Virginia.

1. The "Notice and Description of Shellfish Area Condemnation Number 018-053, Little Oyster Creek and Windmill Point ", effective 29 October 2008, is cancelled effective 2 November 2010.
2. Condemned Shellfish Area Number 018-053, shown as Sections A, B and C, is established effective 2 November 2010. As to Sections A and B, it shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in Section 28.2-810 of the Code of Virginia. As to Section C, it shall be unlawful for any person, firm or corporation to take shellfish from this area, for any purpose. The boundaries of these areas are shown on the map titled "Little Oyster Creek and Windmill Point, Condemned Shellfish Area Number. 018-053, 2 November 2010" which is part of this notice.
3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 018-053

- A. The condemned area shall include all of that portion of the Rappahannock River within a 1500 feet radius defined by latitude/longitude map coordinate (37°36'52.4", -76°17'26.1"); but excluding the area defined as Section C. This coordinate corresponds to a location at the southern most point of the west jetty of the Windmill Point Yacht Harbor entrance.
- B. The condemned area shall include all of Windmill Point Creek upstream of a line drawn between latitude/longitude map coordinate (37°37'33.4", -76°18'13.5") and map coordinate (37°37'21.7", -76°17'47.1").



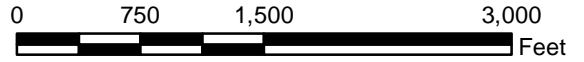

C. The condemned area shall include all of the Windmill Point Yacht Harbor basin inland of a line drawn between latitude/longitude map coordinate (37°36'52.4", -76°17'26.1") and map coordinate (37°36'51.2", -76°17'25.1").
