NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 005-083, LOWER MACHODOC CREEK

EFFECTIVE 15 MAY 2024

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

1. The "Notice and Description of Shellfish Area Condemnation Number 005-083, Lower Machodoc Creek," effective 15 May 2023, is cancelled effective 15 May 2024.
2. Condemned Shellfish Area Number 005-083, shown as Sections A through F, is hereby established, effective 15 May 2024. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Lower Machodoc Creek, Condemned Shellfish Area Number 005-083, 15 May 2024" which is part of this notice.
3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 005-083

- A. The condemned area shall include that portion of Lower Machodoc Creek and its tributaries upstream of a line drawn between latitude/longitude map coordinate (38°06'22.2", -76°38'54.2") and map coordinate (38°06'21.5", -76°38'41.5").
- B. The condemned area shall include all of Cabin Point Creek and its tributaries upstream of a line drawn between latitude/longitude map coordinate (38°08'29.3", -76°39'40.6") and map coordinate (38°08'28.5", -76°39'40.5").
- C. The condemned area shall include all of Branson (Bellfield) Cove upstream of a line drawn between latitude/longitude map coordinate (38°08'30.1", -76°38'20.5") and map coordinate (38°08'28.6", -76°38'09.3").
- D. The condemned area shall include all of Weatherall Creek and its tributaries upstream of a line drawn between latitude/longitude map coordinate (38°07'54.1", -76°39'03.9") and map coordinate (38°07'53.9", -76°39'03.1").

- E. The condemned area shall include all of the unnamed tributary of Upper Machodoc Creek inland and upstream of a line drawn between latitude/longitude map coordinate (38°08'02.2", -76°38'05.5") and map coordinate (38°08'01.0", -76°38'05.9").
- F. The condemned area shall that portion of Glebe Creek at its tributaries upstream of a line drawn between latitude/longitude map coordinate 38°07'37.6", -76°39'15.5") and map coordinate (38°07'40.9", -76°39'11.2").
