NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 020-041, CARTER CREEK

EFFECTIVE 15 OCTOBER 2023

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

- 1. The "Notice and Description of Shellfish Area Condemnation Number 020-041, Carter Creek," effective 15 October 2022, is cancelled effective 15 October 2023.
- 2. Condemned Shellfish Area Number 020-041, shown as Sections A through E, is hereby established effective 15 October 2023. As to Sections A through D; it shall be unlawful for any person, firm, or corporation to take shellfish from these areas, for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. As to Section E, it shall be unlawful for any person, firm or corporation to take shellfish from this area, for any purpose. The boundaries of these areas are shown on the map titled "Carter Creek, Condemned Shellfish Area Number 020-041, 15 October 2023" which is part of this notice.
- 3. Seasonally Condemned Shellfish Area Number 020-041, shown as Section M1, is hereby established effective 15 October 2023, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from this area during such period for any purpose, except by permit granted by Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of this area are shown on the map titled "Carter Creek, Condemned Shellfish Area Number 020-041, 15 October 2023" which is part of this notice.
- 4. Seasonally Condemned Shellfish Area Number 020-041, shown as Section S49 through S51 and S213, is hereby established effective 15 October 2023, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from this area during such period for any purpose, except by permit granted by Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of this area are shown on the map titled "Carter Creek, Condemned Shellfish Area Number 020-041, 15 October 2023" which is part of this notice.



5. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 020-041

- A. The condemned area shall include that portion of the Eastern Branch of Carter Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°39'11.3",-76°24'48.7") and map coordinate (37°39'08.6",-76°24'43.2").
- B. The condemned area shall include that portion of Carter Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°39'26.8", -76°26'15.5") and map coordinate (37°39'25.9", -76°26'03.4"); but excluding the area defined as Section E.
- C. The condemned area shall include that portion of the Eastern Branch of Carter Creek inland of a line drawn between latitude / longitude map coordinate (37°39'15.7", -76°25'24.2") and map coordinate (37°39'14.6", -76°25'09.7").
- D. The condemned area shall include that portion of Bridge Cove upstream of a line drawn between latitude / longitude map coordinate (37°39'30.6",-76°25'42.2") and map coordinate (37°39'31.8",-76°25'38.9").
- E. The condemned area shall include that portion of Carter Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°39'41.8", -76°26'08.0") and map coordinate (37°39'40.5", -76°25'57.6").
- M1. The seasonally condemned area shall include all of Carter Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°39'16.7", -76°26'23.8") and map coordinate (37°39'15.6", -76°25'52.2"); but excludes the areas defined as Sections B and E.
- S49. The seasonally condemned area shall include all of Jacks Cove upstream of a line drawn between latitude / longitude map coordinate (37°39'06.2",-76°25'13.5") and map coordinate (37°39'03.7",-76°25'06.6").
- S50. The seasonally condemned area shall include that portion of Bridge Cove upstream of a line drawn between latitude / longitude map coordinate (37°39'15.8",-76°25'34.6") and map coordinate (37°39'15.7",-76°25'09.7"); but excludes the area defined as Section D.
- S51. The seasonally condemned area shall include all of Yopps Cove upstream of a line drawn between latitude / longitude map coordinate (37°39'02.9",-76°25'49.2") and map coordinate (37°38'58.4",-76°25'51.7").
