**NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION**  
**NUMBER 021-058, EASTERN BRANCH CORROTOMAN RIVER**

**EFFECTIVE 16 NOVEMBER 2016**

Pursuant to Title 28.2, Chapter 8, §§28.2-803 through 28.2-808, §32.1-20, and §2.2-4002, B.16 of the Code of Virginia:

1. The "Notice and Description of Shellfish Area Condemnation Number 021-058, Eastern Branch Corrotoman River," effective 28 October 2014, is cancelled effective 16 November 2016.
2. Condemned Shellfish Area Number 021-058, shown as Sections A through D, is hereby established effective 16 November 2016. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in Section 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Eastern Branch Corrotoman River, Condemned Shellfish Number 021-058, 16 November 2016" which is part of this notice.
3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

**BOUNDARIES OF CONDEMNED AREA NUMBER 021-058**



- A. The condemned area shall include all of Hills Creek and its tributaries lying upstream of a line drawn from latitude/longitude map coordinate (37°42'36.4",-76°27'50.6") to map coordinate (37°42'31.4",-76°27'50.7").
- B. The condemned area shall include that portion of the Eastern Branch of the Corrotoman River and its tributaries lying upstream of a line drawn from latitude/longitude map coordinate (37°43'07.6",-76°26'27.4") to map coordinate (37°42'58.7",-76°26'28.3").
- C. The condemned area shall include all of Bells Creek and its tributaries lying upstream of a line drawn from latitude/longitude map coordinate (37°42'47.8",-76°27'30.3") to map coordinate (37°42'55.9",-76°27'29.4").

D. The condemned area shall include all of the unnamed tributary of the Eastern Branch of the Corrotoman River lying upstream of a line drawn from latitude/longitude map coordinate (37°42'37.7", -76°27'15.3") to map coordinate (37°42'38.8", -76°27'12.3").
