**NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION
NUMBER 042-157, NORTH RIVER**

EFFECTIVE 1 AUGUST 2017

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:


1. The "Notice and Description of Shellfish Area Condemnation Number 042-157, North River," effective 27 May 2015, is cancelled effective 1 August 2017.
2. Condemned Shellfish Area Number 042-157, shown as Sections A through F, is established effective 1 August 2017. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "North River, Condemned Shellfish Area Number 042-157, 1 August 2017" which is part of this notice.
3. Seasonally Condemned Shellfish Number 042-157, shown as Sections S23 and S24, is hereby established effective 1 August 2017, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of August until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from these areas during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "North River, Condemned Shellfish Area Number 042-157, 1 August 2017" which is part of this notice.
4. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 042-157

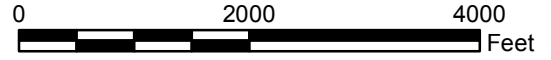
- A. The condemned area shall include that portion of the North River and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°26'40.2", -76°26'46.4") and map coordinate (37°26'39.8", -76°26'36.7").
- B. The condemned area shall include all of Belleville Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°24'35.5", -76°26'09.3") and map coordinate (37°24'33.2", -76°26'04.9").


- C. The condemned area shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°25'01.9",-76°27'29.6") and map coordinate (37°24'57.9",-76°27'29.5").
- D. The condemned area shall include all of Elmington Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°25'20.2",-76°27'10.5") and map coordinate (37°25'16.0",-76°27'11.4").
- E. The condemned area shall include all of Toddsbury Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°25'57.1",-76°27'14.5") and map coordinate (37°25'54.8",-76°27'14.3").
- F. The condemned area shall include all of the unnamed tributary of the North River upstream of a line drawn between latitude / longitude map coordinate (37°25'15.6",-76°25'50.4") and map coordinate (37°25'15.8",-76°25'45.0").
- S23 The seasonally condemned area shall include that portion of Back Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°25'07.0",-76°27'13.0") and map coordinate (37°25'02.6",-76°27'15.5"); but excluding the area defined as Section C.
- S24. The seasonally condemned area shall include that portion of the North River and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°26'20.6",-76°26'48.6") and map coordinate (37°26'15.3",-76°26'31.1"); but excluding the area defined as Section A.


