NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION
NUMBER 088-139, CHERRYSTONE INLET

EFFECTIVE 30 AUGUST 2017


Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia.

1. The “Notice and Description of Shellfish Area Condemnation Number 088-139, Cherrystone Inlet,” effective 27 December 2016, is cancelled effective 30 August 2017.
2. Condemned Shellfish Area Number 088-139, shown as Sections A and B, is hereby established effective 30 August 2017. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas, for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Cherrystone Inlet, Condemned Shellfish Area Number 088-139, 30 August 2017” which is part of this notice.
3. Seasonally Condemned Shellfish Area Number 088-139, shown as Section M1, is hereby established effective 30 August 2017, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from this area during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of this area are shown on the map titled “Cherrystone Inlet, Condemned Shellfish Area Number 088-139, 30 August 2017” which is part of this notice.
4. Seasonally Condemned Shellfish Number 088-139, shown as Section S32, is hereby established effective 30 August 2017, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of August until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from this area during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of this area are shown on the map titled “Cherrystone Inlet, Condemned Shellfish Area Number 088-139, 30 August 2017” which is part of this notice.
5. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

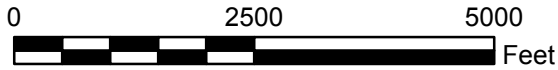
BOUNDARIES OF CONDEMNED AREA NUMBER 088-139

- A. The condemned area shall include that portion of Kings Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°16'45.6",-75°59'33.7") and map coordinate (37°16'41.8",-75°59'34.9").
- B. The condemned area shall include all of Eyrehall Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°18'37.4",-75°59'16.9") and map coordinate (37°18'34.6",-75°59'18.4").
- M1. The seasonally condemned area shall include that portion of Kings Creek upstream of a line drawn between latitude / longitude map coordinate (37°16'58.0",-76°00'38.9") and map coordinate (37°16'54.7",-76°00'38.5"); and downstream of a second line drawn between map coordinate (37°16'51.0",-76°00'20.8") and map coordinate (37°16'41.6",-76°00'19.9").
- S32. The seasonally condemned area shall include that portion of Kings Creek upstream of a line drawn between latitude / longitude map coordinate (37°16'49.6",-75°59'50.2") and map coordinate (37°16'45.9",-75°59'47.5"); but excluding the area defined as Section A.



