The Department permits importers to obtain and maintain Bedding & Upholstery registration on behalf of foreign manufacturers. However, Virginia law does not permit an importer to hold a registration while importing from multiple foreign manufacturers under a single registration. For manufacturer and importers – it is one license per factory. Each manufacturer AND each importer must be licensed in Virginia – there is no joint license.

Virginia law requires one license per factory for both manufacturers and importers.
