The Three Rivers Health District (TRHD) Ryan White (RW) Clinic provides a continuum of HIV wrap-around services for adults living with HIV in the ten counties that make up the health district. TRHD is geographically located in the Eastern Health Region of Virginia. The Three Rivers Health District encompasses an area of over 2,000 square miles. The population of the district is approximately 142,000 and 9 of the 10 counties are considered medically underserved by the Health Resources and Service Administration (HRSA). The district faces many health equity challenges unique to rural areas. One of those challenges is the low number of health care and dental providers within the district that are taking new clients or taking new clients that have Medicaid insurance plans. This restricts clients to the number of care providers in their locality and results in clients having to travel outside of their locality to receive medical and dental care, which can take several hours. Three Rivers clients also have challenges with limited internet and WIFI access. Many areas have "dead spots" for WIFI and internet connection. The pandemic highlighted consumer access to internet services due to the need to access services through telehealth. Many of our clients live in small town communities where confidentiality can be broken. Small town gossip creates stress about possible stigma and everyone knowing about the client's HIV status. This stress increases isolation, which also increases the potential for substance use and abuse. Clients can fall back into habits that are detrimental to their physical and mental health. There are a limited amount of support groups and mental health providers in the district for mental health services. Post pandemic has resulted in most mental health providers being at capacity and unable to take on new clients. There are a limited number of community support groups within the district. Many communities lack staff and interest in providing support groups for any individual in need. Three Rivers Health District faces many health equity challenges and must be creative when assisting clients with finding the resources to allow for the best health outcome in the end. With these challenges also comes partnerships and learning about resources in the rural communities that may be available.

ADDRESSING HEALTH EQUITY AT THE PROVIDER LEVEL

Across the United States, health disparities are persistent in minority communities. With raising rates of immigrants in the United States, health disparities are continuing to affect these individuals.

NovaSalud is a nonprofit organization located in Falls Church, Virginia. Northern Virginia's diverse population comprises of 47% immigrants and 16% of those are Hispanic/Latinx. NovaSalud's mission "is to improve and strengthen the health and well-being of our diverse Northern Virginia Community through culturally competent language, and appropriate STD and HIV/AIDS services: including HIV testing and prevention education free of charge for all." NovaSalud continues to improve Health Equity efforts by making it an organizational strategic priority. NovaSalud provides a team of diverse and inclusive staffing. Eighty-eight percent of staff is bilingual and 100% of staff is ethnically diverse. The Ryan White program consists of 80% Spanish only speaking clients and is supported by three bilingual community health workers. Events in the year 2020 has really affected minority groups and highlighted how difficult it can be to access needed services. NovaSalud's community health workers work diligently to assist Northern Virginia's diverse population. NovaSalud's Prevention program continues to provide culturally competent free HIV and STI testing. Clients have shared, they find discomfort engaging with some health providers in a hospital setting and feel at ease in a more intimate setting with our diverse staff. NovaSalud's continuous health equity efforts means assisting in increasing
