Review and Approval of Minutes:

The minutes of the January 15th, 2025, meeting were reviewed, and amendments were made to correct a minor error. Amy Paulson motioned to approve the minutes as amended, seconded by Gina Harris. The motion passed unanimously.

Impact of Federal Funding on Public Health

Dr. Imrit-Thomas presented the impact that federal funding cuts are having on the agency and the status of other grants under consideration. All discretionary spending is currently paused. Mrs. Allen-Benson reported that with the loss of staffing, current staff members have stepped up to fill the gap and continue to serve the community. Impacted programs include disease control and tobacco cessation.

Other areas impacted by the federal cuts include the loss of several CDC resource websites and availability of printed materials.

Civic league representatives suggested that the community needs to be informed about the impact of the federal cuts on the health department and the city even as increased demands for services are expected through the summer and fall seasons.

Harm Reduction Efforts & Partnerships

Michelle Winz presented current harm reduction efforts and some associated results. Overall, substance overdose deaths for 2024 have gone down, compared to 2023. This work is inclusive of the efforts made by the Peer Recovery Specialist and Overdose Prevention Coordinator.

Biennial Board Nomination/Vote

The biennial voting of officers was conducted. James Overton motioned to nominate Dr. Melody Armstrong and Rev. Suzanne Stierwalt counsel chairperson and vice chairperson, respectively. The motion was seconded by Ray Smith. All members, present and not employed by the Portsmouth Health Department, voted and unanimously to approve the motion. Their two-year term will be effective at the start of the next quarter, July 1, 2025.

Old Business:

Accreditation Finalized

Dwight Richards presented the final decision and plaque from the Public Health Accreditation Board. The accreditation is good for the next five years with annual reports due each year.

Follow-up/Reports:

Ray Smith reported a coalition of 15 of 39 civic leagues across the city agreed to work together to better represent the voices of the community.

Dr. Imrit-Thomas reported that Portsmouth City Manager will be hosting a Government 101 series aimed at educating citizens about the varies city departments and the work they do.

Reverend Stierwalt announced the National Day of Prayer event scheduled for City Park on May 1, 2025.

Amy Paulson reported on activities involving the Healthy Portsmouth Coalition, including the Bon Secours imaging center that was scheduled to be open in early May. Healthy Portsmouth have conducted about 900 blood pressure screenings to date. A regional Stop Syphilis conference is scheduled for April 29, 2025, at ODU student center. Healthy Portsmouth Faith-based Coalition is seeking faith partners.
