Background

The Virginia Stroke Systems Task Force (VSSTF) is an independent body comprised of stakeholders invested in improving stroke systems of care in Virginia. The VSSTF is not an advisory body for the Virginia Department of Health (VDH). The role of VDH is to provide administrative support to the VSSTF.



VSSTF Structure


- Co-chairs
 - Two year term; staggered
 - Elected by VSSTF voting members
- Voting members
 - Listed positions are based on 2014 VSSTF Guidance
 Document with noted modifications
 - Two year term; staggered
 - Open nomination, except organizational representatives
 - Selected by co-chairs
 - Member may be reappointed for additional two year terms
- Nonvoting members

VSSTF Guidance Document 2014 Commitments of Voting Members

- Attend VSSTF meetings on a regular basis- at least two annually
- Make recommendations and help carry out VSSTF initiatives
- Leverage influence/resources to positively impact development of Virginia's stroke systems in the community
- Commit an average of 2-4 hours per month, not including needed travel time, during a two year term



VSSTF Guidance Document 2015 Member Qualifications and Characteristics

- Ascribe to the guidelines presented in the ASA Policy Statement Recommendations for the Establishment of Stroke Systems of Care
- Be a recognized expert in stroke systems and/or one or more of the components of a stroke system of care
- Be in a position to help effect systems change on a statewide or regional scale
- Be willing to share ideas in a cooperative forum
- Deal with other members fairly, sensitively and confidently
- Be open to diverse opinions and points of view



Process for determining 2020 voting members

- Identified position vacancies by comparing 2016 VSSTF membership list with attendance for past 4 VSSTF meetings
- Active voting members will retain their position x1 year
 - Membership will expire 1/2021 and position opened for nominations
 - Allows voting memberships to be staggered



Process for determining voting members

- Call for nominations for vacant positions (10/2019)
- Co-chairs selected the representative for voting membership positions with multiple nominees
 - Criteria outlined in the VSSTF Guidance document
 - Member commitment
 - Qualifications and characteristics
 - Equitable Health Planning Region representation

Position: VSSTF Co-chair

Roles and Responsibilities:

- The VSSTF Co-Chair shall provide strategic direction and leadership for the VSSTF.
- The VSSTF Co-Chair must attend and facilitate VSSTF quarterly meetings.
- The VSSTF Co-Chair shall collaborate with the other VSSTF Co-Chair, VSCC Co-Chairs, VDH representative, and other members of the VSSTF planning team to ensure proper planning of meetings (Bi-weekly/monthly conference calls), represent interests of VSSTF members, triage member correspondences for streamlined communication, and facilitate the nomination process.

Nomination Eligibility:

- Licensed physician or nurse. The physician can be a neurologist, emergency physician or another specialist, but must have experience and expertise in diagnosing and treating cerebrovascular disease. The nurse can be a stroke coordinator or member of a hospital's acute stroke team.
- Must actively participate in VSSTF quarterly meetings.
