  - Open nomination, except organizational representatives
  - Selected by VSSTF co-chairs
  - Member may be reappointed for additional two year terms
- Nonvoting members


## VSSTF Guidance Document 2014 Commitments of Voting Members

- Attend VSSTF meetings in-person on a regular basis- at least two annually
- Make recommendations and help carry out VSSTF initiatives
- Leverage influence/resources to positively impact development of Virginia's stroke systems in the community
- Commit an average of 2-4 hours per month, not including needed travel time, during a two year term

# **Timeline for Nominations**

- Nomination survey will be sent after the October 14, 2022 meeting.
- Deadline for nominations will be Friday, November 18, 2022.
- Voting members will be selected by the VSSTF Co-Chairs and notified in December 2022.
- New Voting Members will be announced at the January 2022 meeting. Selected Voting Members are required to attend in person in at the January 13, 2023 VSSTF meeting.
