Attachment 2

Equivalency

All BIL projects are required to be equivalency projects. Additionally, projects funded by the FY26 DWSRF Base funding listed below are equivalency projects.

- WSL-010-26 Applachia, Town of
- WSL-011-26 Rapidan Service Authority

Disadvantaged

All projects provided principal forgiveness “PF” in the Notes column of the Project Priority List (PPL) for the DWSRG Base and BIL General Supplemental, are disadvantaged.

- The DWSRF Base grants funded projects listed above as equivalent, as well as non-equivalent DWSRF projects funded by repayments from previous years are designated in Attachment 1 with a “WSL” prefix and are located in the first or “top” section of the PPL.
- The BIL/IIJA General Supplemental grant funded projects are designated with an “S” after the second number as in this example “BIL-023S-25”. These projects are located in the second section from the top of the PPL.
- Additionally, Floyd-Floyd County PSA in the BIL/IIJA Emerging Contaminants project is disadvantaged in the third section from the top of the PPL. The BIL/IIJA Emerging Contaminants grant funded projects are designated with an “C” after the second number as in this example “BIL-010C-26”.
- The BIL/IIJA Lead Service Line grants funded projects are listed in the fourth or bottom section from the top of the PPL. The BIL/IIJA grant funded projects are designated with an “L” after the second number as in this example “BIL-012L-24”.

Assistance to Small Systems

As evidenced in the “Service Connections” column of the PPL, the majority of the systems receiving assistance serve fewer than 10,000 people and would be designated as small systems. Only four projects serve waterworks with more than 10,000 people. Those include:
