Annual Priority Workgroup

The 2024 Annual Priority Workgroup pivoted away from CLABSI due to changes in NHSN's mandatory race/ethnicity reporting. This led to a shift in focus towards disparities in sepsis throughout Virginia. The workgroup created an educational document outlining disparities in sepsis, recommendations for improvement, and showcasing effective strategies in the field. The educational resource, shared with VDH infection preventionists and VHAG members, also played a key role in raising awareness about mandatory NHSN reporting in 2025.

Safe Antibiotic Stewardship Innovators (SASI) Workgroup

The SASI workgroup continued its efforts to promote optimal antimicrobial use. The focus in 2024 was on nursing home education and antimicrobial use and resistance data. This year's accomplishments include:

- Participating in U.S. Antibiotic Awareness Week
- Developing three education documents for nursing homes to improve antibiotic use
- Gaining feedback from committee members on NHSN antibiogram functions and potential statewide uses
- Gaining feedback from committee members on NHSN antibiotic use data; have used the feedback for critical access hospital data reports
