NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 008-214, COAN RIVER

EFFECTIVE 15 APRIL 2023

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

1. The “Notice and Description of Shellfish Area Condemnation Number 008-214, Coan River,” effective 15 March 2022, is cancelled effective 15 April 2023.
2. Condemned Shellfish Area Number 008-214, shown as Sections A, B and C, is hereby established, effective 15 April 2023. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Coan River, Condemned Shellfish Area Number 008-214, 15 April 2023” which is part of this notice.
3. Seasonally Condemned Shellfish Area Number 008-214, shown as Sections M1 and M2, is hereby established effective 15 April 2023, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Coan River, Condemned Shellfish Area Number 008-214, 15 April 2023” which is part of this notice.
4. Seasonally Condemned Shellfish Area Number 008-214, shown as Sections S5 and S6, is hereby established effective 15 April 2023, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Coan River, Condemned Shellfish Area Number 008-214, 15 April 2023” which is part of this notice.
5. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

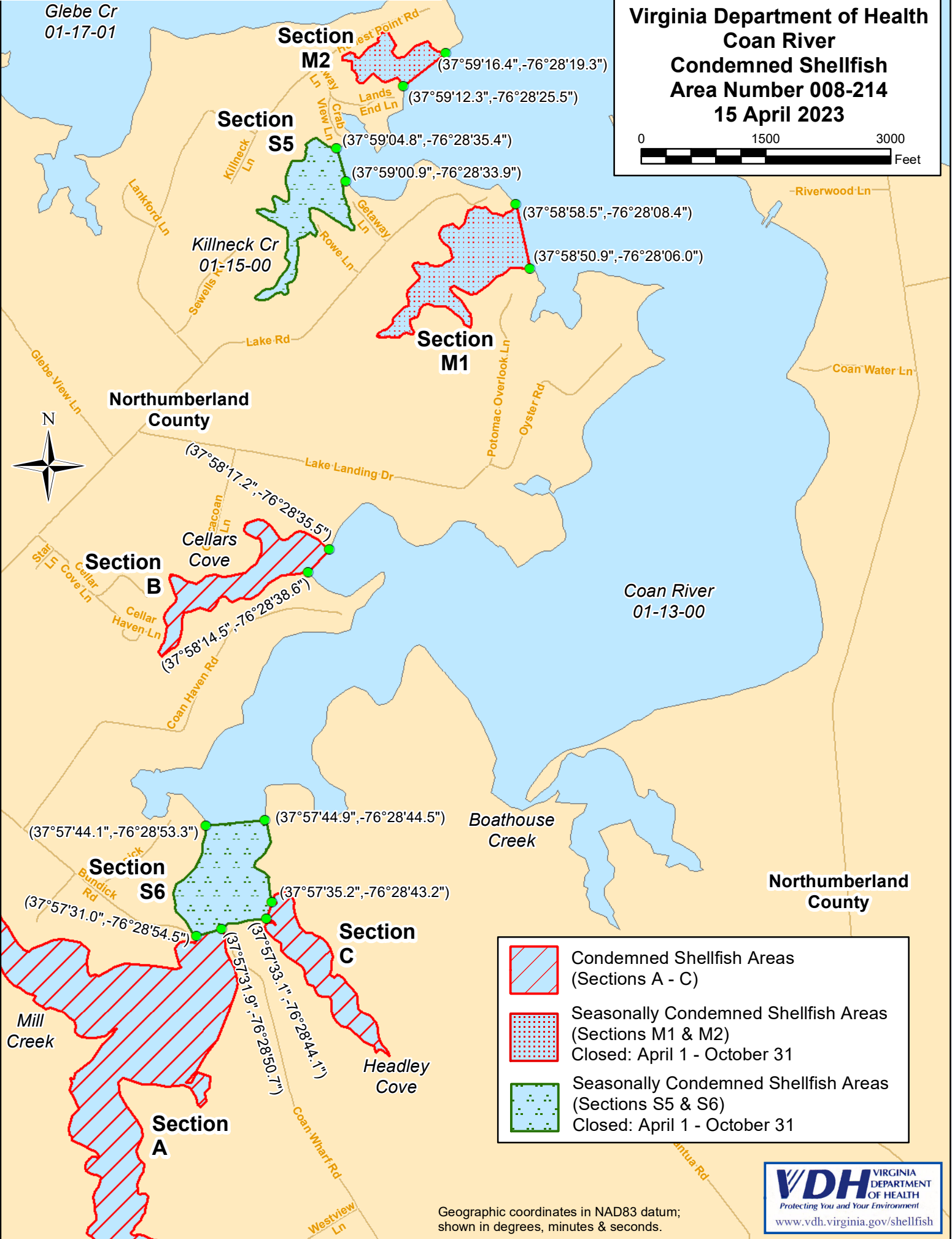
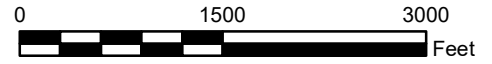
BOUNDARIES OF CONDEMNED AREA NUMBER 008-214

- A. The condemned area shall include that portion of the Coan River and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°57'31.0", -76°28'54.5") and map coordinate (37°57'31.9", -76°28'50.7").
- B. The condemned area shall include that portion of Cellars Cove upstream of a line drawn between latitude / longitude map coordinate (37°58'17.2", -76°28'35.5") and map coordinate (37°58'14.5", -76°28'38.6").
- C. The condemned area shall include all of Headley Cove upstream of a line drawn between latitude / longitude map coordinate (37°57'33.1", -76°28'44.1") and map coordinate (37°57'35.2", -76°28'43.2").
- M1. The seasonally condemned area shall include all of the unnamed tributary of the Coan River south of Killneck Creek upstream of a line drawn between latitude / longitude map coordinate (37°58'58.5", -76°28'08.4") and map coordinate (37°58'50.9", -76°28'06.0").
- M2. The seasonally condemned area shall include all of the unnamed tributary of the Coan River north of Killneck Creek upstream of a line drawn between latitude / longitude map coordinate (37°59'16.4", -76°28'19.3") and map coordinate (37°59'12.3", -76°28'25.5").
- S5. The seasonally condemned area shall include that portion of Killneck Creek upstream of a line drawn between latitude / longitude map coordinate (37°59'04.8", -76°28'35.4") and map coordinate (37°59'00.9", -76°28'33.9").
- S6. The seasonally condemned area shall include that portion of the Coan River and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°57'44.1", -76°28'53.3") and map coordinate (37°57'44.9", -76°28'44.5"). but excludes the areas defined as Sections A and C.
