NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION
NUMBER 047-078, ABERDEEN, CARTER AND CEDARBUSH CREEKS
EFFECTIVE 15 AUGUST 2022

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia.

1. The "Notice and Description of Shellfish Area Condemnation Number 047-078, Aberdeen, Carter and Cedarbush Creeks," effective 15 August 2021, is cancelled effective 15 August 2022.
2. Condemned Shellfish Area Number 047-078, shown as Sections A through D, is established effective 15 August 2022. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Aberdeen, Carter and Cedarbush Creeks, Condemned Shellfish Area Number 047-078, 15 August 2022" which is part of this notice.
3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 047-078

- A. The condemned area shall include all of Aberdeen Creek upstream of a line drawn between latitude/longitude map coordinate (37°20'16.0", -76°35'30.8") and map coordinate (37°20'13.8", -76°35'30.7").
- B. The condemned area shall include that portion of Carter Creek and its tributaries upstream of a line drawn from latitude/longitude map coordinate (37°18'53.5", -76°34'25.0") to map coordinate (37°18'52.8", -76°33'58.0").
- C. The condemned area shall include that portion of Cedarbush Creek and its tributaries upstream of a line drawn from latitude/longitude map coordinate (37°18'40.0", -76°33'23.8") to map coordinate (37°18'34.5", -76°33'20.2").

D. The condemned area shall include all of the unnamed tributary of Cedarbush Creek upstream of a line drawn from latitude/longitude map coordinate (37°18'48.0", -76°33'41.9") to map coordinate (37°18'43.8", -76°33'35.1").

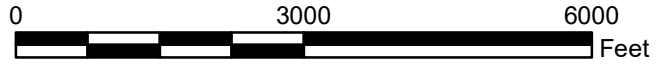
