NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 097-219, FINNEY CREEK

EFFECTIVE 5 SEPTEMBER 2013

Pursuant to Title 28.2, Chapter 8, §§28.2-803 through 28.2-808, §32.1-20, and §2.2-4002, B.16 of the *Code of Virginia*:

1. The "Notice and Description of Shellfish Condemnation Number 097-219, Finney Creek," effective 26 April 2011 is cancelled effective 5 September 2013.
2. Seasonally Condemned Shellfish Area Number 097-219, shown as Section M1, is established effective 5 September 2013, and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from this area during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in §28.2-810 of the *Code of Virginia*. The boundaries of this area are shown on the map titled "Finney Creek, Condemned Shellfish Area Number 097-219, 5 September 2013" which is part of this notice.
3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 097-219

- M1. The seasonally condemned area shall include all of that portion of Finney Creek south of a line drawn from latitude / longitude map coordinate (37°36'34.0",-75°40'54.7") to map coordinate (37°36'32.4",-75°40'52.5"), and north of a line drawn from map coordinate (37°35'51.0",-75°41'15.0") to map coordinate (37°35'52.4",-75°41'04.6"), and inland of a third line drawn across the Wachapreague Channel between map coordinate (37°35'57.5",-75°40'49.4") and map coordinate (37°35'54.0",-75°40'49.7").

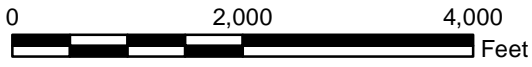


