Dear Mr. Smith:

This letter is to request an exemption from the requirements of the ***Commonwealth of Virginia Sanitary Regulations for Marinas and Boat Moorings*** to one or more of the following, please check appropriate items:

- Sanitary facilities – 12, VAC 5-570-120
- Sanitary waste pump-out facilities – 12, VAC 5-570-180
- Sewage dump-station facilities – 12 VAC 5-570-190

Restroom Exemption

- Adequate sanitary facilities are located within **1000** feet from the shore end of the pier at each residence of the subdivision or housing complex or at the associated restaurant, lodging establishment, commercial establishment. Sanitary facilities will be available to users of the facility at all times that boats may be occupied. Overnight occupancy is prohibited and signs must be posted. Bathrooms will be available: _____.

OR

- Portable toilets will be provided due to the lack of available water and sewage connections. These portable toilets will be placed within **500** feet of the shore end of the pier. These portable toilets will be available during the boating season (typically April through October). The facilities will be maintained according to the service contract. (***The portable toilet service contract needs to be submitted along with this exemption request.***)

Sewage Pump-Out Exemption

- The facility will not allow boats with installed toilets to moor at this facility. Overnight occupancy of boats will be prohibited and a sign will be placed at the pier instructing users of the facility that the discharge of sewage or other waste material overboard will not be allowed.

OR

- Alternate Pump-Out Agreement** – Vessels having a Type III Marine Sanitation Device will be directed to the marina for which we have an Alternate Pump-out Agreement. A sign will be posted at the dock stating the location of the Alternate Pump-Out Agreement. This alternate pump-out location is within three nautical miles of our facility. Enclosed you will find the signed Alternate Pump-Out Agreement. (*Person requesting exemption needs to provide the Alternate Pump-Out Agreement with the Exemption Request.*)

Sewage Dump Station Exemption

- Users of the facility will be required to use their own sanitary facilities as a sanitary waste dump station.

OR

- Contents from portable toilets will be disposed of into the restroom or portable toilet and a sign shall be posted instructing users of the facility that the portable toilet or restroom serves as a sewage dump station.

OR

- A pumpout is available - the facility will provide an wand attachment device for the pumpout to allow pumping the contents from portable sewage containers.
