NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 009-142, HULL CREEK

EFFECTIVE 15 MARCH 2024

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

- 1. The "Notice and Description of Shellfish Area Condemnation Number 009-142, Hull Creek," effective 15 March 2023, is cancelled effective 15 March 2024.
- 2. Condemned Shellfish Area Number 009-142, shown as Sections A through F, is hereby established effective 15 March 2024. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Hull Creek, Condemned Shellfish Area Number 009-142, 15 March 2024" which is part of this notice.
- 3. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration of revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 009-142

- A. The condemned area shall include that portion of Hull Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°55'53.5",-76°23'01.6") and map coordinate (37°55'53.5",-76°22'56.0").
- B. The condemned area shall include all of Fleets Cove and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°56'22.9",-76°23'24.4") and map coordinate (37°56'20.4",-76°23'20.8").
- C. The condemned area shall include that portion of Rogers Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°57'08.8", -76°22'50.0") and map coordinate (37°57'06.5",-76°22'50.3").
- D. The condemned area shall include all of Corbin Pond and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°57'39.6",-76°24'05.7") and map coordinate (37°57'39.0",-76°24'03.5").

- E. The condemned area shall include all of Floyd Cove and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°56'18.5",-76°22'59.7") and map coordinate (37°56'13.3",-76°22'56.6").
- F. The condemned area shall include all of Fountain Cove and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°56'44.1", -76°23'31.9") and map coordinate (37°56'37.1", -76°23'30.9").
