NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION NUMBER 034-126, WILTON, COBBS, AND HEALY CREEKS

EFFECTIVE 15 JANUARY 2025

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

1. The "Notice and Description of Shellfish Area Condemnation Number 034-126, Wilton and Cobbs Creeks," effective 15 December 2023, is cancelled effective 15 January 2025.
2. The "Notice and Description of Shellfish Area Condemnation Number 034-208, Moore and Healy Creeks," effective 15 December 2022, is cancelled effective 15 January 2025.
3. Condemned Shellfish Area Number 034-126, shown as Sections A through D, is hereby established effective 15 January 2025. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled "Wilton, Cobbs, and Healy Creeks, Condemned Shellfish Area Number 034-126, 15 January 2025" which is a part of this notice.
4. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 034-126

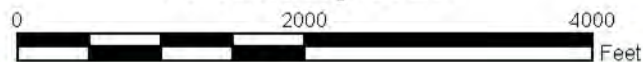
- A. The condemned area shall include that portion of Wilton Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°31'14.2", -76°25'01.9") and map coordinate (37°31'15.6", -76°24'55.8").
- B. The condemned area shall include all of Cobbs Creek upstream of a line drawn between latitude / longitude map coordinate (37°31'32.9", -76°24'10.2") and map coordinate (37°31'35.7", -76°24'07.8").
- C. The condemned area shall include all of the unnamed tributary of Wilton Creek upstream of a line drawn between latitude / longitude map coordinate (37°31'10.8", -76°25'06.1") and map coordinate (37°31'09.6", -76°25'06.1").

- D. The condemned area shall include that portion of Healy Creek and its tributaries lying upstream of a line drawn between latitude/longitude map coordinate (37°32'31.2", -76°23'42.3") and map coordinate (37°32'29.8", -76°23'38.0").
