**NOTICE AND DESCRIPTION OF SHELLFISH AREA CONDEMNATION
NUMBER 034-208, JACKSON, MOORE, AND CORES CREEKS**

EFFECTIVE 15 JANUARY 2025

Pursuant to Title 28.2, Chapter 8, §§ 28.2-803 through 28.2-808, § 32.1-20, and § 2.2-4002, B.16 of the Code of Virginia:

1. The “Notice and Description of Shellfish Area Condemnation Number 034-208, Moore and Healy Creeks,” effective 15 December 2022, is cancelled effective 15 January 2025.
2. The “Notice and Description of Shellfish Area Condemnation Number 033-084, Jackson Creek,” effective 15 December 2023, is cancelled effective 15 January 2025.
3. Condemned Shellfish Area Number 034-208, shown as Sections A through E, is hereby established effective 15 January 2025. It shall be unlawful for any person, firm, or corporation to take shellfish from these areas for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Jackson, Moore, and Cores Creeks, Condemned Shellfish Area Number 034-208, 15 January 2025” which is a part of this notice.
4. Seasonally Condemned Shellfish Area Number 034-208, shown as Sections M1 through M3, is hereby established effective 15 January 2025 and shall remain in force annually thereafter for the period beginning the first day of April through the last day of October until rescinded. It shall be unlawful for any person, firm or corporation to take shellfish from these areas during such period for any purpose, except by permit granted by the Marine Resources Commission, as provided in § 28.2-810 of the Code of Virginia. The boundaries of these areas are shown on the map titled “Jackson, Moore, and Cores Creeks, Condemned Shellfish Area Number 034-208, 15 January 2025” which is a part of this notice.
5. The Department of Health will receive, consider and respond to petitions by any interested person at any time with respect to reconsideration or revision of this order.

BOUNDARIES OF CONDEMNED AREA NUMBER 034-208

- A. The condemned area shall include that portion of the western prong of Jackson Creek upstream of a line drawn between latitude / longitude map coordinate (37°32'41.9", -76°20'15.5") and map coordinate (37°32'45.6", -76°20'12.8").

- B. The condemned area shall include all of Porpoise Cove lying upstream of a line drawn between latitude/longitude map coordinate (37°32'13.4", -76°21'11.1") and map coordinate (37°32'12.5", -76°21'10.1").
- C. The condemned area shall include all of Moore Creek and its tributaries lying upstream of a line drawn between latitude/longitude map coordinate (37°32'09.7", -76°21'26.5") and map coordinate (37°32'10.0", -76°21'25.3").
- D. The condemned area shall include all of Cores Creek and its tributaries lying upstream of a line drawn between latitude/longitude map coordinate (37°32'22.4", -76°22'19.5") and map coordinate (37°32'22.3", -76°22'18.0").
- E. The condemned area shall include all of the unnamed cove of Jackson Creek upstream of a line drawn between latitude / longitude map coordinate (37°32'40.0", -76°19'48.0") and map coordinate (37°32'40.0", -76°19'41.3").
- M1. The seasonally condemned area shall include that portion of the Piankatank River lying inland of a line drawn between latitude/longitude map coordinate (37°32'10.0", -76°21'25.3"), map coordinate (37°32'09.5", -76°20'41.8"), and map coordinate (37°32'12.9", -76°20'41.9"); but excludes the area defined as Section B.
- M2. The seasonally condemned area shall include that portion of the Piankatank River and Fishing Bay lying inland of a line drawn between latitude/longitude map coordinate (37°32'19.8", -76°20'23.1") and map coordinate (37°32'29.5", -76°19'55.4").
- M3. The condemned area shall include all of Jackson Creek and its tributaries upstream of a line drawn between latitude / longitude map coordinate (37°32'40.0", -76°19'41.3") and map coordinate (37°32'49.3", -76°19'17.1"); but excluding the areas defined as Sections A and E.
