	Office of EMS has been using tests generated by the Atlantic EMS Council; however, the	
	Atlantic EMS Council will discontinue test generation in 2013. This is due in part because of	
	states moving towards National Registry.

He explained that the SAFE (Substance Abuse Free Environments, Inc.) is a coalition in Chesterfield County. He said that they work to save lives, reduce injuries, protect family, and strengthen the economy by preventing and reducing substance abuse.</li> <li>Mr. Frith gave a lot of information regarding their work to reduce the use and abuse of inhalants.
