<b>Call to Order – Gary Critzer, Chair</b>	<p>Mr. Critzer called the meeting to order at 1:04 PM</p> <p><u><i>Pledge of Allegiance</i></u> – Mr. Critzer began the meeting by asking everyone to stand for the Pledge Allegiance to the Flag.</p> <p><u><i>Approval of August 10, 2012 Meeting Minutes</i></u>- The minutes from the August 10, 2012 State EMS Advisory Board meeting were approved as submitted.</p> <p><u><i>Approval of November 7, 2012 Meeting Agenda</i></u>- The meeting agenda was approved as submitted.</p>	
<b>Chairman’s Report – Gary Critzer</b>	Mr. Critzer deferred his report until the Executive Committee report.	
<b>Vice Chair Report – Dale Wagoner</b>	Mr. Wagoner informed the Board that Benny Summerlin, a dedicated EMS volunteer who served the EMS community in various roles, and was a member of the State EMS Advisory Board had recently died. A scholarship has been established in his name, the Benny Summerlin Scholarship that will award scholarships to worthy individuals pursuing a college degree that will lead to a career in public safety.	
<b>Deputy Commissioner of Public Health &amp; Preparedness – Marissa Levine, MD</b>	<p>Dr. Levine reported on the change in leadership at VDH. Dr. Karen Remley has left her position as Commissioner of the Department of Health. Dr. Maureen Dempsey has been appointed as the Acting Health Commissioner. Dr. Dempsey was the Chief Deputy before assuming the position of Acting Health Commissioner. Dr. Levine has been asked to assume the interim position of Acting Chief Deputy in addition to her other duties.</p> <p>Dr. Levine acknowledged the Norfolk Health Department for once again offering flu vaccinations to EMS Symposium attendees.</p>	
<b>Office of EMS Report – Gary R. Brown, Director</b>	Mr. Brown welcomed the audience to the 33 <sup>rd</sup> annual Virginia EMS Symposium. Mr. Brown reminded the audience of the free flu vaccination being offered by the Norfolk Health Department. He also reminded the group of the Governor’s Awards Ceremony being held on Saturday night.

	<p><u>National Association of State EMS Officials Annual Meeting</u> Mr. Brown reported that NASEMSO held its annual meeting in Boise, Idaho in September. He reported on some of the highlights that took place during the annual meeting.</p> <ul style="list-style-type: none"> <li>❖ OEMS Staff Members Elected to Serve on National Committees Mr. Brown pointed out some of the OEMS employees who continue to serve on national committees. Paul Sharpe, the Trauma and Critical Care Manager, was selected as president-elect of the Data Managers Council. David Edwards, the EMS for Children Coordinator, assumed the chairmanship of the Pediatric Emergency Care Council. In addition, Mr. Brown reported that he was elected to the NASEMSO Board of Directors as the East Region alternate. During a recent NASEMSO Board of Directors meeting, Mr. Brown was also named Treasurer. After being elected Treasurer, Mr. Brown had to give up the East Region alternate position on the Board of Directors; but he will still serve on the Board of Directors, since he is the Treasurer.</li> <li>❖ MCI MUCC Implementation Mr. Brown reported that currently the Federal Interagency Committee on EMS (FICEMS) is developing a MUCC (Model Uniform Core Criteria) implementation plan for mass casualty triage. He said that the vast majority of states and local jurisdictions are currently utilizing the START (Simple Triage and Rapid Treatment) plan for Mass casualty triage. Therefore, NASEMSO unanimously passed a resolution asking FICEMS to look at the evidence of MUCC (the Model Uniform Core Criteria) versus START and the cost of the implementation plan and asking FICEMS to include provisions that will allow sufficient grants and support to states and local jurisdictions to help them with transition and implementation.</li> <li>❖ NFPA 1917 Ambulance Standards Mr. Brown reported that the NFPA 1917 Ambulance Standards that are replacing the KKK specs were scheduled to go into effect October 1, 2013. However, he said there has been a lot of discussion on these standards nationally and issues on the way they are written. NASEMSO passed a unanimous request to the Feds requesting a two-year delay of the retirement of the KKK specs. The GSA has agreed to a one year delay but would not promise a two-year delay. NASEMSO has petitioned for two years, and the EMS community will be updated of the final decision.</li> </ul> <p>Mr. Brown reported that currently there are actually three sets of ambulance standards (KKK specs, NFPA specs, and the ASTM specs). NASEMSO has worked with the manufacturers, and the manufacturers have done a crosswalk of the three documents and specifications. This document has been posted on the NASEMSO website.</p> <ul style="list-style-type: none"> <li>❖ National Registry Update Bill Brown from the National Registry of EMTs, who will be retiring, gave a presentation on proposed plans and projects at the National Registry.</li> </ul>	<p><b>OEMS will keep the EMS community informed on the outcome of the request for a two-year delay of implementation of the NFPA 1917 Ambulance Standards.</b></p>

The first day is in the classroom and the second day is the operational course. Dr. Lindbeck thanked Dan Norville for all his assistance in making the operational course possible.</p> <p><u>Scope of Practice Grids</u> Dr. Lindbeck reported that the Scope of Practice grids have been updated. <p><b>Standing Committee Reports and Action Items</b></p>		
<p><b>Executive Committee – Gary Critzer</b></p>	<p>The committee met at the Office of EMS on November 1. It was a very productive meeting. Discussion items included:</p> <ul style="list-style-type: none"> <li>➤ The recertification waiver legislation, that did not make it on Governor’s legislative agenda last session, has been picked up by a delegate; and is pending for the next session.</li> <li>➤ EMS Plan Revision. Mr. Winston informed them that the EMS Plan draft revisions will be going out to the various committees of the board so they can review sections applicable to their committee.</li> <li>➤ The Executive Committee reaffirmed the commitment of the State Medical Protocols Guideline Workgroup’s work under the Medical Direction Committee.</li> <li>➤ Board appointments still have not been made. Hopefully they will soon be made.</li> <li>➤ Putting together a NEMESIS 3 Workgroup as a VPHIB users group. They are recruiting individuals who utilize the various software packages to create a users group to help with technical issues.</li> <li>➤ A meeting will be scheduled with Dr. Dempsey, the Interim Health Commissioner, along with Dr. Levine, Gary Brown, Scott Winston and Gary Critzer sometime in December to discuss EMS issues.</li> <li>➤ A scheduled Senate Finance subcommittee panel meeting on funding affecting the Health Department was postponed due to the State of Emergency. EMS had been asked to do a presentation on EMS funding. The presentation has been prepared, and will be given once the meeting is rescheduled.</li> <li>➤ Mr. Critzer will be attending a meeting of the Health and Human Services Subcommittee of Commonwealth Preparedness on December 12. He is also attending the State Fire Chiefs Executive Committee meeting in the morning of the 12<sup>th</sup>.</li> </ul>	<p><b>Inform Mr. Critzer of individuals, familiar with one of the third party vendors such as Firehouse or EMS Charts, who are willing to serve on the workgroup.</b></p>
<p><b>Financial Assistance Review Committee – Amanda Davis</b></p>	<p>The committee will meet on Thursday, November 8 at 1PM. They will be reviewing the requests for the upcoming cycle. They received grant applications requesting \$9.3 million in funding this cycle. They received 52 requests for ambulances this cycle, as well. Both of these numbers are high in comparison to the last cycle.</p> <p>They changed the conditions for communications equipment this cycle from P25 compliant to P25 compatibility.</p>

<p><b>Administrative Coordinator – Gary Samuels</b></p>		
<p><b>Rules and Regulations Committee – Gary Samuels</b></p>	<p>The Rules and Regulations committee last met in August. The Governor has signed the EMS Regulations, and they took effect on October 10, 2012. OEMS staff has almost completed updating the template applications and other required paperwork. Mr. Samuels said they are progressing with the Infectious Control Officer Training Program outline and the Drug and Alcohol Model templates.</p> <p>The committee has sent requests to VML and VACO asking for a representative to fill the last vacant seat on the Rules and Regulations committee.</p>	
<p><b>Legislative and Planning Committee – Chris Eudailey</b></p>	<p>Mr. Eudailey reported that the committee is working on the State EMS Plan, which is due to the State Board of Health to be adopted and approved by March of 2014. He reminded the committees that they need to review the areas of the plan relevant to their work and make comments and edits. OEMS will be sending out a template to all standing committee to assure that the format will be consistent when revisions are received from each committee.</p> <p>State EMS Needs Assessment – the working committee is doing a final review of the assessment instrument. They anticipate that this will be sent to all licensed EMS agency in the Commonwealth in the near future. They ask that each agency respond, and they would like to have only one response from each agency.</p> <p>The legislative session will be starting soon. Mr. Eudailey asked that board members let Mr. Winston or him know of any legislation that they may be aware of that may be coming up in the session.</p>

<p><b>Trauma System Oversight &amp; Management Committee – Paul Sharpe</b></p>	<p>Mr. Sharpe reported that they have modified their contract with Image Trend to start utilizing their trauma registry product to replace their existing product. This will bring trauma and EMS data into one system. They are rewriting the Trauma data dictionary minimum data set and that will be brought to the Board sometime early 2013.</p> <p>The Trauma Center Designation Manual was accepted by the Health Commissioner on behalf of the Board of Health.</p> <p>The Trauma Performance Improvement Committee is continuing to meet. The Office of EMS will be hosting the Trauma Outcome Performance Improvement Committee course in December.</p>	<p><b>The Trauma Oversight &amp; Management Committee will present a draft of the rewritten Trauma data dictionary minimum data set to the Board sometime in early 2013.</b></p>
