	Easton explained that it is important to use this tracking system for the right events such as Patient Exit Points (PEP), MEDCOMM and Transport Recorder working together (under Transportation Group Supervisor) and at the hospital (arrival or thereafter) to update vitals, add photos, etc.	
	The first project was started around 2001 or 2002 in Prince Georges County, but was not sustained. The second project of this type was started in 2008 for a regional patient tracking system. The current system has been in use for about two years. It was designed to follow the same flow as a triage tag. There are many problems with manual patient tracking during an MCI event. Good records are not kept as to where a patient has been transferred. They get lost. An electronic patient tracking system is better at tracking the whereabouts of patients. Patient accountability is why NOVA is doing this. Easton explained the problems that occur with the device and the interaction with the system in Maryland and Washington, DC. The system was obtained through a UASI grant.	
	Kelly stated that the Northern VA system does integrate with VHAS. However, the hospitals are still doing manual input and still trying to integrate HL7 data feeds. The hospital IT departments are working on this and is piloting it in several hospitals. This is still a work in progress.	
	Chief Hoback asked what steps would be needed to get the electronic patient tracking system in other areas. Karen explained that funding may be an issue. A special grant may have to be initiated for this. She suggested finding a grant that the Office of EMS could apply for to fund this system after we figure out how much funding would be needed based on the number of units needed at each agency.	
	Chief Hoback stated that the network connectivity is the expensive part. How do we make the infrastructure available and let the individual agencies come on board as an option? Karen stated that we can try, but it will be met with roadblocks. Chief Hoback would like OEMS to look into it. He is interested in knowing from the vendor, what the software costs are. Easton will check on software costs.	
	Chief Hoback asked if the committee wants to form a study group on this tracking system. He will send out an email to the committee to see who would like to be on this group. Mike Player is interested in the study group. Bubby Bish will also join the group.	
Unfinished Business:	Update on Model Uniform Core Criteria (MUCC) – Karen Owens The National Highway Traffic Safety Administration (NHTSA) is doing some pilot and training programs with MUCC. Per Karen, other States are not aware of this. This is still on hold until there are some definite plans from the Federal Government to roll with MUCC. MCI I & II is still being used and the triage tags will remain
