	D. State EMS Plan – Chris Vernovai	
	The State EMS Plan was reviewed and approved by the Legislative and Planning Committee on October	
	23 <sup>rd</sup> . This past Wednesday it was approved by the Advisory Board and will go before the State Board of	
	Health in either December or March.	
	E. DICO Clarification – Chris Vernovai/Valerie Quick	
	Valerie stated that about a month and a half ago, she met with the Office of the Chief Medical Examiner	
	to talk about the issues that surround drawing decedent blood. They have been very receptive about	
	coming up with changes to meet the potential need for collecting the blood for testing. They are supposed	
	to be coming up with recommendations. There was also discussion about legislation. At this point, the Office of EMS does have a way to get blood tested. There is no other agency that can test decedent blood	
	for HIV, Hepatitis B and Hepatitis C, which are the three main tests. The biggest recommendation coming	
	out of this is to consolidate resources and streamline the process.
