### EMS Physician Community

Based on the date this question was submitted and with ongoing preparations for the Virginia EMS Symposium, there was not enough time to formulate and implement a survey to Virginia’s EMS Physicians.

### **3. What certified or licensed healthcare profession (if any) does not have clinical training as part of their education?**

The Commission on Accreditation of Allied Health Education Programs (CAAHEP) manages an accreditation system for most, if not all allied health programs. CAAHEP has nationally-recognized Standards.

All CAAHEP Standards have certain elements in common, however the Standards for each discipline contain specific requirements for training entry level practitioners in that profession. The Standards are approved by the CAAHEP Board of Directors and are subject to review every five years.

The Standards review process is a rigorous one that includes, input from the communities of interest, a public open hearing, and approval by the Committee on Accreditation (CoA) and its sponsoring organization(s).

The January 2021 [CAAHEP Policies and Procedures Manual](#) states that Committee’s on Accreditation (CoA’s) for each allied health program area must ensure that:

#### ***III - C – Curriculum:***

The curriculum content must ensure that the program goals are achieved. Instruction must be based on clearly written course syllabi that include course description, course objectives, methods of evaluation, topic outline, and competencies required for graduation. Instruction must be delivered in an appropriate sequence of classroom, laboratory, and **clinical activities**.

The program must demonstrate that the curriculum offered meets or exceeds the (CoA determines ‘content’ or ‘competencies’) listed in Appendix B of these Standards.

(Instruction to CoA: Clinical activities may be substituted with supervised practice experiences if clinical affiliates are not applicable to the profession)

CAAHEP supports and encourages innovation in the development and delivery of the curriculum.

Based on this guidance to CoA's, it is the opinion of the ACE Division Staff that most, if not all recognized allied health programs require a clinical component, to be defined by the CoA, in conjunction with the program, for a student to be eligible for certification testing.
