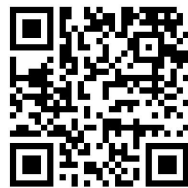

## Mayday, FIREFIGHTER DOWN -

**Dates:** September 17-18, 2022 – 08:00 to 17:00

**Instructor:** Tom Nelson, Ladd Grindstaff

**Description:** The 16-hour Mayday Operations - A course designed for all members of the fire service from the chief to the newest member. The mission of this class is two-part: first, is to provide training for every member of the team to survive the worst event on the fire ground. Second, is to provide chief officers with training to administrate a "two-in/two-out" program and how to meet this standard, self-rescue techniques, flashover recognition, how to train and use a Rapid Intervention Team, tactical considerations for RITs, building construction for firefighter safety, fire fighter accountability and other safe fire ground operations.

**Hours:** 16

**Prerequisites:** Firefighter I

**Class size:** 24 Students

**Student Equipment:** FF PPE with SCBA

**Curriculum Text:** Provided to registered students through CSOD

## Rural Water Supply

**DATE:** September 17-18, 2022 - 8:30 - 5:00

**Instructor:** TBD

**Description:** A course designed for the rural fire department that depends heavily on tanker shuttles to provide water at the fire ground. Course consists of classroom training on equipment needed, apparatus placement on the fire ground and the fill site, safety and extensive hands on training conducting tanker shuttles under realistic conditions.

**Audience:** Both firefighters, apparatus operators and those that want to plan a role in the delivery of water in a rural environment.

**Hours:** 16

**Prerequisites:** None

**Student Equipment:** Helmet, Gloves and Safety Footwear

## ICS-300: Intermediate ICS for Expanding Incidents

**Dates:** September 16, 2022 – 18:00 to 22:00

September 17-18, 2022 – 08:30 – 17:00

**Instructor:** Wayne Hoover

**Description:** - Designed for those emergency response personnel who would function in a Command or General Staff position during a large, complex incident or event or personnel who are or would likely be part of a local or regional Incident Management Team during a major incident, whether single agency, multi-agency or Unified Command.

**Audience:** Members who would likely be part of a IMT.

**Hours:** 20

**Prerequisites:** IS-100, IS-200, IS-700 and IS-800

**Class size:** 24 students

**Student Equipment:** Provided to registered students through CSOD.

## Rope Rescue Operations

**Dates:** September 17-18, 24-25, 2022 – 8:30 – 5:00 pm

**Instructor:** VDFP HTR Instructor Cadre

**Description:** A course designed to provide an opportunity for fire and rescue personnel who can demonstrate proficiency in basic rope rescue skills to further their knowledge.

**Audience:** Classroom and skills exercises will be utilized to prepare advanced students to remove victims from above and below grade situations. Includes extensive information on rigging and haul back systems.

**Hours:** 32

**Prerequisites:** Must be 18 years of age. Must be a member in good standing with a recognized fire, EMS or public safety agency/department. Shall be psychologically, physically and medically capable to perform assigned duties and functions at technical rescue incidents and to perform training exercises in accordance with NFPA 1500. Must have HMO, Introduction to Technical Rescue Module I and II, and Rope Rescue Operations.

**Class size:** 24

**Student Equipment:** Helmet, leather gloves and boots, eye protection or FF PPE

**Curriculum Text:** NFPA 1006

## HTR Vehicle Rescue Operations (Level I)

**Dates:** September 17-18, 2022 - 8:30 -5:00

**Instructor:** VDFP HTR Instructor Cadre

**Description:** This program meets or exceeds the requirements for NFPA 1006 Standards for Technical Rescuer Professional Qualification, Chapter 10, Level 1. The students will learn to perform at the Operations Level as specified in NFPA 1670, Standards on Operations and Training for Technical Search and Rescue Incidents, Chapter 8.

This 16 hour program includes classroom and practical training in Common passenger vehicle anatomy, systematic approach to vehicle rescue incidents, common passenger vehicle stabilization, incident hazard isolation, access and egress of common passenger vehicles, disentanglement of victims, the packaging and removal of victims for a common passenger vehicle, and operating as a member of a rescue team and directing rescue operations.

**Audience:** Members that respond to and operate at vehicle incidents.

**Hours:** 16

**Prerequisites:** Introduction to Technical Rescue – Module II

**Class size:** 24

**Student Equipment:** Helmet, leather gloves and boots, eye protection or FF PPE

**Curriculum Text:** NFPA 1006/1670

## VAOEM EMS Officer 1

**Dates:** September 17-18, 2022 - 8:30 – 5:00

**Instructor:** VA OEMS Instructor Cadre

**Description:** Upon successful completion of this course, the student will be able to effectively manage EMS agency operations and administration. Major topics covered in this course are the role of the EMS officer, facing compliance and accountability issues of the 21st century, recognizing and managing cultural diversity, safety/wellness, TQM, interfacing with the community and media at large, functional leadership, effective communications, incident management system(s) and managing multiple casualty incidents. Students will need a computer.

**Audience:** BLS Providers (EMT), ALS Providers EMS Officer 1 is targeted for the entry-level officer serving as the Crew Leader or AIC. Target, Administrators, Educators

**Hours:** 16 in class, plus six – eight hours pre course work, CE Hours: 24 CE hours (cat. 2) will be awarded.

**Prerequisites:** Minimum age of 18, Hold a current Virginia Certification of EMT or higher, No corrective action from EMS Agency, OMD, or OEMS, Submit copies of NIMS 100, 200, 700, 800 certificates or FEMA Transcript, Review all video presentations. Complete all homework assignments prior to class.

**Class Size:** Minimum of 24, Max of 30

**Student Equipment:** Bring a computer to class, Casual Business Attire or station uniform

**Curriculum Text:** None

## Elevator Rescue

**Dates:** September 17-18, 2022 – 08:30 – 5:00

**Instructors:** Kevin Bartal, Tony Carroll and others

**Description:** The Elevator Emergencies course is designed to provide the emergency provider with the knowledge, skills and abilities to respond to elevator emergencies. It will show the provider how to safely remove people from malfunctioning elevators by providing them with a working knowledge of both traction and hydraulic elevators. The use of elevators during fire emergencies will also be discussed. The course consists of 4 hours classroom followed by hands on familiarization and expands into practical skills and applications.

**Audience:** Members that operate with or support, a rescue team and directing rescue operations.

**Hours:** 16 maximum

**Prerequisites:** Students shall be psychologically, physically, and medically capable to perform assigned duties and functions at technical rescue incidents and to perform training exercises in accordance with of NFPA 1500 *Standard on Fire Department Occupational Safety and Health Program*, Chapter 10-Medical and Physical Requirements

**Class size:** 24 students

**Student Equipment:** Helmet, leather gloves and boots, eye protection or FF PPE, station uniform or other suitable attire no shorts.

**Curriculum Text:** None

## Firefighter I & II – Train-the-Trainer

**Dates:** September 17-18, 2022 – 08:30 – 5:00

**Description:** Firefighter 1 & 2 train the trainer provides the guidance necessary for delivering a quality Firefighter 1 & 2 1001-19 edition programs. The material covers the Administrative Guidelines for Firefighter 1 & 2, overviews the two (2) approved curriculums, reviews the resource package, and the classroom and practical material as well as review of testing procedures. During the train the trainer, the process for new candidates shall be clearly explained and includes time to answer questions related to this program delivery. All candidates must attend 100% of this program.

This is not a certification course. Students will receive VDFP training hours and a Certificate of Attendance

The components of the train the trainer for Firefighter I & II 1001-19 edition are:

Pretest - The Firefighter 1 & 2 Train the Trainer NFPA-1001-19 Standard. Contains thirty-five questions from NFPA-1001-13 that came from SCBA, Ground Ladders, Forcible Entry, Search, Interior Attack, Horizontal Ventilation, Vertical Ventilation, Extinguishers, and Hose JPR's. Fifteen questions from the NFPA-1041-12 Standards with at least one question for each of the Instructor I JPR's.

Classroom session – Review of the program, paperwork, skills and student teach back

Field Instruction – Demonstrate knowledge of the FF 1 & 2 program delivery and Knowledge of Instructor related information. This is accomplished with Instructor teach backs during in person train the trainer and validation of shadow time\* by jurisdiction.

Classroom Shadow time – minimum classroom instruction two subject's affidavit submitted to Division Chief signed by Instructor that verified instructional time

Completion of Live Fire Training Practical as live fire crew leader, signed off by an Instructor with current VDFP FF 1 & 2 TtT. Online –Course if available through the COVLC and/or CSOD.

## Driver Pump Operator – Train-the-Trainer
