In an effort to help keep our educators and providers informed and to prevent random blocking of e-mail messages from ISP's, the ACE Division is launching the GovDelivery email message service to facilitate dissemination information to the public.

With so many different smartphone software versions, smartphone/tablet manufactures, ISP's and e-mail services, it has become more difficult for the ACE Division to be able to guarantee that end users are receiving our bulk messages.
