Mr. Watkins seconds and the motion passes.</li> <li>Ms. Carter explains to the committee that after a meeting with ESO there have been bigger issues than they originally anticipated, and they have set up a workgroup at the OEMS office the following afternoon in hopes to collectively resolve some of the issues.</li> <li>Ms. Pomphrey, Mr. Capewell, and Ms. Tracey Taylor volunteer to join the workgroup at OEMS. Ms. Quick inquiries about next steps of the manual. Ms. Carter informs the committee that the office has been working with the manual, it was retyped by an intern over the summer, and it is currently a major project in the office.
