Program Update – Tim	The amount of data submitted to the Medevac Helicopter EMS application (formerly known as WeatherSafe)	
Perkins:	continues to be robust. In terms of weather turndowns, there were 354 entries into the Helicopter EMS system in Q4 of the 2022 calendar year. 68% of those entries (244 entries) were for interfacility transports, which is consistent with information from previous quarters. The total number of turndowns is an increase from 316 entries in Q4 of 2021. For the 2022 calendar year, there were 1,445 entries into the system, which was an increase from the 1,282 entries for the 2021 calendar year. This data continues to demonstrate a commitment to the program and maintaining the safety of medevac personnel and equipment. Every agency is consistently submitting information. b. Unfinished Business:	a. Medevac Resource Guide – Tim is still waiting on the license for RTIS to be updated so he can recreate the map in a higher definition.	
	b. Committee Composition Updates – This afternoon, Tim is going to present the Advisory Board Executive Committee with the list of the new Medevac Committee representation for the remainder of 2023. We are expanding the committee by four members. If this is approved this afternoon, please do your best to attend the meetings so that quorums are met and know that your participation is expected at each meeting. The dates for the remainder of the year are on the agenda. We are not sure about the November meeting date, which is tentative. Tim also spoke about proxies, which was discussed at the last meeting. The seat belongs to you, so no one else can fill your seat. They are welcome to attend the meeting, but if you are not here, your vote does not count. There will be a total of 18 committee members including Tim. There must be at least 51% of the members present to have a quorum according to Robert's Rules. Public Comment:	Air Medical Transport Data Mike Watkins presented data from the 2 nd Quarter of 2022. He reported that there were 362 trauma patients transported by an air medical unit, 34 of which were pediatric transports; 19 went to a Level I trauma center and 15 went to a pediatric trauma center so more than half went to non-pediatric designated facility. Sixty-four were geriatric transports, of which, 89% went to a Level I trauma center, 6 went to a Level II trauma center and one was taken to a non-trauma hospital. We are looking at outliers like that one patient that went to a non-trauma hospital. Two-hundred and sixty-three were adult transports, most went to a Level I trauma center, nine went to a Level II, one was transported to a Level III and 5 was transported to a non-trauma hospital. This data allows us to review the outliers and may or may not identify the reasons behind them. The last thing that Mike wants to mention is that the Trauma Triage Guideline is changing. A Virginia guidance document is being prepared to reflect the American College of Surgeons (ACS) changes. Regulations Update A committee member asked about an update on the Regulations that were revised some time ago. Mr. Ron Passmore, OEMS, gave an update on the status saying that the final draft of the Regulations has been reviewed by all the committee and the particle of the parameter.	Responsible Ferson
	by all the committees. It will be submitted at the next Advisory Board meeting for approval. If approved, it will then go to the State Board of Health for final approval in September. Then it will go to stage 2 of the regulatory process, once it clears the Executive Branch review, it will be publicly posted for comments which may be two years from September.
