# **Retailer Advisory Meeting Minutes**

- The meeting began at 2:00pm
- Paula Garrett (WIC Director) provided an update for the WIC division
  - Reminder about waivers: Added eggs such as medium & XL, jumbo, and brown eggs. Milk is allowed in
    flexible varieties for now (If a participant is prescribed whole milk, retailers may sell regular, lactose free
    whole milk, or UHT whole milk. If a participant is prescribed low-fat/fat free milk, retailers may sell skim,
    1%, 2%, regular lactose free or UHT milk)
  - Compliance & monitoring visits are paused with a waiver from USDA
  - Participant app is 3-6 months out. This will allow participants to see their personal shopping list with words and pictures, they can scan a UPC to see if it's approved, and can find the retailer nearest them.
  - USDA announced a grant opportunity with a research university to look into investigating online ordering for WIC. This will not be a quick turnaround, but we're excited at the prospect.
- Megan Nason (Program Manager) provided an update for the program
  - Food waivers through 9/30/20. Amy reminded attendees that eggs would need to be submitted to us for approval.
  - Egg and milk waiver details are attached to the end of these minutes.

- Alex Acharya (WIC Vendor Compliance Manager) provided an update for the vendor team
  - 2020 Reauthorization: All contracts expire this year.
  - All retailers will need to complete interactive training and sign new retailer agreements. We have hosted webinars for independent retailers. All other stores are provided a video that will need to be used for training. Since interactive training is required, all retailers must conduct training by showing this video WHILE BEING LIVE on a webinar or in person in order to answer questions. The person on the webinar to count as "interactive" must be either a certified trainer or a WIC staff member. The Video is here: 2020 Reauthorization training video.

  - Reminder to all that only one cashier handbook is required per store.
- Jarene Fleming (State Breastfeeding Coordinator) provided an update on a new Virginia law, Pregnant Worker
   Fairness Act

- New law that went into effect July 1 affects all employers with five or more employees. This includes provisions to ensure breastfeeding mothers are provided with a **private** location **other than a bathroom** to express breastmilk. Lactating women must also be allowed longer and more frequent breaks, though they are not required to be paid.

## **Temporary Eggs Waiver Due to COVID-19**

Due to the COVID-19 crisis, eggs have been reported to be one of the most difficult to locate at the grocery stores. USDA has given us the green light to allow additional sizes of eggs at this time. We will allow one dozen medium, large, extra-large and jumbo sizes of white or brown, regular or organic eggs to be temporarily added until further notice.

#### BUY:

- Medium, Large, Extra-Large or Jumbo size eggs
- White or Brown
- Regular or Organic

### DON'T BUY:

- Cage Free
- Free Range
- Fat/Cholesterol Altering Eggs (Eggland's Best)

## **Temporary Milk Waiver Due to COVID-19**

The Virginia WIC Program has learned that a significant number of WIC retailers are having trouble in maintaining certain inventory of WIC eligible milk products for participants due to the COVID-19 crisis. As a result, USDA has approved the temporary waiver for milk products.

If the prescribed milk product is unavailable for purchase, WIC participants can buy other milk products as shown below:

• If WIC participants are prescribed Whole Milk, retailers are allowed to sell regular, lactose-free whole milk or UHT whole

• If WIC participants are prescribed Low-Fat/Fat-Free Milk, retailers are allowed to sell skim (fat free), 1%, 2% regular, lactose-free or UHT milk.

This temporary milk waiver is effective March 31, 2020 until further notice. Store cashiers should scan all milk items first to see if they can go through instead of telling a WIC participant that they are not WIC approved.
