The Spring season is a great reminder of how wonderful change can be. The Virginia WIC Program is fully embracing all the change that is forthcoming. The longawaited new food rules for the WIC food packages have been published. The WIC food packages are periodically reviewed to ensure they are meeting the nutritional needs of our participants and are in line with the most current science. The goal of the new food rules will be to allow more choices and flexibility for WIC participants as well as

accommodate special dietary needs as well as personal and cultural food preferences. These new food packages will be implemented within the next two years.

The WIC 2024 Food List and Retail Formula Flyer have been printed and shipped to our storage warehouse. The team at the State WIC Office will be working over the next few weeks to get food lists and formula flyers to our local agency clinics and the authorized retailers. Electronic versions are available already on our webpage in English and Spanish. There have been no major changes to the 2024 food list outside of updated pictures and products. Look out for your shipment of the paper copies within the next sixty days.

As always, we thank you for your support to the Virginia WIC Program and look forward to our continued partnerships.

2024 New WIC Food List and Retail Formula Flyer Update

The electronic version of the <u>2024 WIC Food List</u> and Retail Formula Flyer (English and Spanish versions) are now available on our website.

Both the new 2024 WIC Food List and Retail Formula Flyer have been printed. A starter packet will be shipped directly to your store within the next sixty days. Be sure to look for a brown envelope with the green label above.

Please remember to scan items to confirm that they are WIC approved before denying the item.

It is important that you take the following steps:

1. Discard all the 2022 WIC Food Lists remaining at your store.

2. Place copies of the new 2024 WIC Food List and Retail Formula Flyer at each eWIC register.

3. Place copies of the new 2024 WIC Food List and Retail Formula Flyer in your Retailer Store binder.

4. Provide training to your cashiers and store personnel so all are aware of the new 2024 WIC food list.

5. Order additional WIC Food Lists (English or Spanish), if needed: <u>VirginiaWICRetailers.com</u>

6. Ensure "Wholesome Informed Choices" (WIC) shelf labels or custom labels are posted for all foods that have this requirement (use the WIC shelf label icon in the Food List).

WIC Retailer Supplies Are Free!

The Virginia WIC Program now offers an easy and fast way to order WIC Retailer Supplies online. The webform allows you to order approved food lists, window decals and many useful tools to train your staff.

Before ordering consider this checklist:

C. Is your store's WIC vendor manual accessible and up to date?

WIC Compliance Update

All WIC approved food items are eligible for a supply validation. The below process is specific to Infant Formula and other items that follow a similar process. Federal regulations require the WIC Program to ensure that authorized stores only sell Infant Formula purchased from an approved supplier/distributor. To achieve the desired outcome, State Agency staff will:

- 1. Review selected stores' contract Infant Formula purchasing records
- 2. Confirm that the supplier identified by the store is authorized by VA WIC*
- 3. Compare formula redemptions to total Infant Formula sales
- 4. Complete a beginning and ending physical inventory of Infant Formula at selected stores

WIC authorized stores are required to maintain at least twelve months of their latest Infant Formula purchase records from all sources and make them available to the State Agency upon request. As part of the Supply Validation, the latest four months of Infant Formula purchase records will be reviewed. The additional eight months of records may be required. It is critical that you ensure your store complies with this requirement and can produce these purchasing records within the timeframes of Supply Validation period. Monitoring Visits

When a WIC representative from the comes to conduct an unannounced store monitoring visit the primary focuses are validating the WIC Minimum Stocking and WIC shelf labels. In preparation for the visit, please verify you have all required foods in stock using the chart below and

locate your WIC Retail Store binder. Each Retail Store binder should have:

- Retail Formula Flyer
- Cashier's Handbook
- Directory of WIC Staff
- Retail Store Manual (An electronic version is available on our website <u>VirginiaWICretailers.com</u>). Use the print option to print a copy or use <u>Supply</u> <u>Request Form</u> to order a printed copy.

Virginia WIC Minimum Stocking

The minimum stocking requirement (MSR) must be met at all times. The products must be in the store during normal business hours. Expired foods do not count toward the requirement. Use the Approved Product List (APL) and the Approved Food List to determine approved brands, varieties, and UPCs that may be used to meet the MSR.

Important note: Mandatory shelf labels are identified in the last column.

Specific Cheese Guidelines for Minimum Stocking Requirements:

The cheese subcategory is the area of the Minimum Stocking Requirements (MSR) that has the most questions.

Sliced cheese - only 16 oz American (NOT individually wrapped) **must** be used to meet the minimum stocking requirement. (blended cheese food or cheese products are not allowed) More information can be found in the current Food List.

Blocked cheese, even though other varieties such are mozzarella are approved; **only** 16oz **cheddar** can be used to meet the MSR.

Q. Where do I find the latest WIC program updates?

Answer: <u>The WIC Retailer Resources</u> web page contains the latest training materials, manuals and the Approved Product List (APL) which is available for download. Access retailer information all in one convenient place <u>Virginia WIC Retailers web site</u>. See the <u>Notices and Updates</u> section for recent updated information

Q. Where can I get more Food lists and other WIC materials?

Answer: There are 3 ways to order WIC materials.

- Online Supply form on VA WIC website under Resources
- Print Supply form and follow the instructions.
- Call your WIC Vendor Liaison (Click here for the directory).

Q. What WIC materials should I have at each eWIC register?

Answer: Current Food List (2024) and Retail Formula flyer

Q. Where should I store the Cashier's Handbook?

Answer: Each store needs only one copy, and it should be stored in the WIC Retail Store binder.

Q. Do I need to sign a new VA WIC Retailer Agreement this year?

Answer: Contract reauthorization for WIC authorized retailers is every three years. All WIC authorized retailers signed the current agreement in 2023. The next year to renew the agreement is 2026.
