Instructions for Form Use

A. All submissions for changes to the Approved Product List must be made by completing and submitting a UPC Update Request Form.

Effective Date: 1/12/2016

- B. All submissions must be WIC-approved foods identified in the current WIC Approved Food List or Infant Formula Flyer. This form may not be used to submit future Food List change requests.
- C. Each UPC update request must be submitted on a separate form.
- D. Complete all applicable sections:
 - 1. Mark submitter type. Local agency representatives are not required to enter WIC ID number.
 - 2. Enter store name, store phone number, date submitted to the State WIC Office, contact name, and email address.
 - 3. Mark only one of three update options.
 - 4. For product additions, enter UPC (12-characters, 9-99999-9999-9), food category (of the following choices: Beans (Dry), Beans (Canned), Bread (Whole Wheat), Brown Rice, Cheese, Eggs, Fish, Fruits, Infant Cereal, Infant Food, Infant Formula, Juice (Frozen), Juice (Liquid), Milk (Soy), Milk (Whole, Reduced Fat), Peanut Butter, Tortillas (Whole Wheat), Tortillas (Corn), and Vegetables), manufacturer name, food description (including flavor, type, added ingredients, etc.), brand name, package size, item price, quantity in single package, and mark availability type and promotional eligibility type.
 - 5. For product changes, enter UPC. Other fields are optional but should be completed if they have changed.
 - 6. For product deletions, enter UPC, food category, manufacturer name, food description, brand name, and package size. The comments field should contain the reason for the proposed deletion and the proposed effective deletion date.
 - 7. Attach container label images including UPC code and ingredients and list number and description of attachments.
