How to Apply to Become a National Health Service Corps Site

Wednesday, April 13, 2022 at 3:00 PM ET



Are you interested in becoming a National Health Services Corps (NHSC) Site? There's help. Facilities that meet the NHSC eligibility requirements can now apply to become a NHSC site. NHSC-approved sites provide outpatient, primary health care services to people in Health Professional Shortages Areas. Becoming an NHSC-approved site will help you to recruit, hire, and retain clinicians. In FY 2020, approximately 14,000 primary, dental, and mental healthcare providers served in National Health Service Corps programs, receiving federal funding in exchange for providing care in a Health Professional Shortage Area.

Uplift Appalachia Survey

Uplift Appalachia provides education and training on to churches and faith-based organizations to motivate and equip them to serve those living with addiction and mental health challenges. Uplift is doing some additional data collection with a survey to learn how people who live with addictions perceive the church and employers and how well the church understands addiction. It asks about what people know about addiction, what they think the church's role in addressing it is, their views of how employers feel about employing people who struggle with addiction, their own religious commitment, and their own substance use. It's anonymous.

Billing for Telehealth Encounters- An Introductory Guide on Medicare Fee-For-Service

The Center for Connected Health Policy (CCHP) is providing this informational billing guide to assist those who have questions regarding telehealth billing. The guide is primarily about Medicare fee-for-service billing as policies vary from state-to-state for Medicaid and commercial payers.

The purpose of the guide is to clarify:

- telehealth billing and reimbursement
- current legislation dictating billing requirements
- requirements applicable during calendar year 2022 (in a non-PHE environment)
- the requirements relevant only during the periods of PHE extensions

VDH Office of Drinking Water Financial Assistance - American Rescue Plan Act (ARPA)



Application Deadline: Friday, May 6, 2022

The Virginia General Assembly allocated the Office of Drinking Water (ODW) \$100 million from the American Rescue Plan Act (ARPA) to improve drinking water infrastructure over the next four years. ODW is leading the Drinking Water Infrastructure Initiative to manage the use of these funds.

The Drinking Water Infrastructure Initiative aims to:

- Improve drinking water infrastructure across the state
- **Assist small and disadvantaged communities**
- Conduct research on consumer confidence reports and having tap water as a trusted drink of choice instead of sugary beverages

ARPA funding is **ONLY available to waterworks that have a population below 10,000 persons**, or that are disadvantaged, abandoned, or have acute or chronic violations of the Waterworks Regulations.

Elder Justice Innovation Grants - Enhancing APS Approaches to Cases Involving Opioids and Substance Use Disorders

Application Deadline: Tuesday, May 3, 2022

Supports the development and advancement of new and emerging issues related to elder justice. Funded projects will contribute to the improvement of the field of elder abuse prevention and intervention at large, such as by developing materials, programs, etc. that can be widely disseminated and/or replicated, or by establishing and/or contributing to the evidence-base of knowledge. For this opportunity, projects will be sought which seek to identify effective strategies and solutions that are expected to maximize the impact of direct home-and community-based social, health, and mental/behavioral health services for APS clients impacted by the opioid epidemic and other substance use disorders.

HRSA Public Health Scholarship Program

Application Deadline: Wednesday, June 1, 2022

HRSA's Bureau of Health Workforce will invest \$39 million for 26 awards. Awarded recipients will provide scholarships to individuals for public health training in professional, graduate, and/or certificate programs. Eligible applicants are government entities, nonprofit organizations, and academic institutions with an existing public health training program and partnerships that can transition students into employment.
