# How will we submit our quarterly reports?

You will submit quarterly reports via REDcap. These reports will be required and used to capture progress for sub-recipients (grantee) activities.

# Will there be a preprinted form, with specific criteria that needs to be reported, for the quarterly reports?

No, preprinted form will be provided. Quarterly reports will be submitted only and through RedCap a pre-formatted report to fill out.

# Strategies, Activities, and Outcomes

Can a religious org/house of worship propose a community-based project in collaboration with a local hospital (that does not provide clinical care). For example, rural hospitals serve disadvantaged rural communities. Could a religious org/house of worship propose a health education series that includes speakers from the local rural hospital?

FBOs are able to partner with hospitals for project programming and initiatives.

# Scope of Work/Services (Strategies and Activities)

This grant program will address COVID-19-related health disparities and advance health equity by expanding state, local, US territorial and freely associated state health department capacity and services to prevent and control COVID-19 infection (or transmission) among populations at higher risk and that are underserved, including racial and ethnic minority groups and people living in rural communities. All strategies should aim to build infrastructures that both address disparities in the current COVID-19 pandemic and set the foundation to address future responses.
