CDC opening applications for Monkeypox Vaccine Equity Pilot Program

"The Centers for Disease Control and Prevention (CDC) have developed a program, called the **Monkeypox Vaccine Equity Pilot Program** to "support innovative, non-traditional ways to address disparities" with regards to monkeypox vaccinations. The CDC is accepting applications from local, state, and territorial health departments, as well tribal governments and local non-governmental organizations in an effort to increase vaccination access to populations most at risk for monkeypox virus.


'We've been at the table': Tribes in Virginia join forces with Indian Health Service

Describes the joint efforts of 7 tribes that recently secured federal recognition with the Indian Health Service (IHS) to create 2 health centers and 3 mobile units that will increase tribal health services in various areas of Virginia. Discusses the close partnership between the tribal governments and IHS to provide culturally aware healthcare services and other tribal community developments through ongoing work with county and federal governments.

Recovery Ecosystem Index (REI) Mapping Tool

The term "Recovery Ecosystem" is used to describe the community-level factors that are in place to support individuals in recovery from substance use disorder (SUD). This tool, released by, NORC at the University of Chicago, East Tennessee State University, and the Fletcher Group, Inc., allows community organizations, policymakers, researchers, and the general public to create county-level



maps to understand these factors in their communities and where additional resources are most needed to provide support to individuals in recovery. Insights derived from this tool can be used to target resources and interventions to enhance recovery ecosystems.

CMS Proposes Changes to Streamline Medicaid, CHIP, and Basic Health Program

Deadline to Submit Comments: Monday, November 7, 2022

The Centers for Medicare & Medicaid Services (CMS) published a proposed rule that would make changes to simplify the processes for eligible individuals to enroll and retain eligibility in Medicaid, the Children's Health Insurance Program (CHIP), and the Basic Health Program.

Medicaid is an important source of health care coverage for rural America, **covering nearly a quarter of individuals under age 65 living in rural areas**. Of interest to rural stakeholders, CMS is seeking comment on whether States either should be permitted or required to update beneficiary contact information based on information obtained from specific groups including providers like Federally Qualified Health Centers and Rural Health Clinics.

HHS Introduces Roadmap for Behavioral Health

The U.S. Department of Health & Human Services (HHS) introduced the Roadmap for Behavioral Health Integration. The paper explains policy and programs that will build three pillars of the national strategy: 1) *Strengthen System Capacity* by developing a diverse workforce; 2) *Connect Americans to Care* through health financing; and 3) *Support Americans by Creating Healthy Environments* with investments in behavioral health, upstream prevention, and recovery. The Roadmap includes rural

communities as part of its equity priority.


Virginia Youth Tobacco Projects Small Grants Program

Preventive Medicine Residency

Application Deadline: Monday, November 21, 2022



Purpose: To increase the number, quality, and diversity of preventive medicine residents and physicians to support access to preventive medicine and to integrate population health with primary care to improve the health of communities.

Eligible entities:

- (a) Accredited school of public health or school of medicine or osteopathic medicine;
- (b) An accredited public or private nonprofit hospital;
- (c) A State, local or tribal health department; or
- (d) A consortium of two or more eligible entities as described in items a, b, or c.

2023 Virginia Walkability Action Institute (VWAI)

VWAI works with local and regional individuals and teams to develop and implement policy, system, and environmental (PSE) changes in local communities. Our goal is to increase access to opportunities for physical activity, employment, education, recreation and more by bringing together a diverse group of professionals, advocates, and champions to address local mobility and moveability issues. Participants consist of local/regional teams and individuals. Each receive training and technical assistance, both in-person and virtually. All participants develop a detailed action plan to pursue a PSE change to improve mobility and moveability in their community.
