

National Lead Poisoning Prevention Week is October 23rd - October 29th!

Health care providers play a critical role in childhood lead poisoning prevention, by screening children at risk for lead exposure, educating families and caregivers on lead poisoning prevention strategies, and ensuring children exposed to lead receive the proper follow-up care.



In Virginia, all children at **increased risk** for lead exposure must get a blood lead test at ages 1 & 2, or up to age 6 if they have not yet received a blood lead test. Please click the button below to review the Virginia Blood Lead Testing & Case Management Protocol.

Medication Assistance Program (MAP) to Assist Qualifying Community Members in Obtaining Eyeglasses

The Medication Assistance Program (MAP) is designed to help supply free medications for Southwest Virginia residents who are either without prescription coverage or who are currently in the Medicare Coverage Gap "donut hole." These medications are provided by using The Pharmacy Connection, which has direct contact with pharmaceutical companies.

MAP can now help qualifying children and adults in receiving free eyeglasses. Eyeglasses are provided free of charge with no additional costs to the qualifying patient. Adults qualify for one pair of eyeglasses per year and children qualify for two pair per year.

ARC J-1 Visa Waivers

ARC is committed to helping residents of Appalachia have access to quality, affordable health care. Accordingly, under certain conditions, ARC will consider recommending a waiver of the foreign residence requirement on behalf of physicians holding J-1 Visas in Health Professional Shortage Areas to address the Region's healthcare needs. The physicians receiving these waivers must practice full-time at a site in a Health Professional Shortage Area (HPSA) within the legislatively defined

Appalachian Region for a minimum of three years.

Million Hearts Health Equity Implementation Project

Application Deadline: Tuesday, November 1, 2022

The resources provided through this opportunity are intended to support work in reducing health disparities. Applicants must select at least one priority population and strategy outlined in Million Hearts® 2027 Focusing on Health Equity, such as "expanded cardiac rehabilitation access or offerings in rural areas." Competitive applicants will be anchored in the populations and strategies central to Million Hearts® 2027 focus on health equity.

Primary Care Training and Enhancement- Residency Training in Mental and Behavioral Health (PCTE-RTMB)

Application Deadline: Tuesday, November 15, 2022

Training for primary care residents in the prevention, identification, diagnosis, treatment, and referral of services for mental and behavioral health conditions for those who at-risk or have experienced abuse, trauma, or mental health and/or substance use disorders. Funding must be used to support both didactic training and at least a one-month clinical rotation primarily focused on mental and behavioral health conditions.

ARC Launches New Funding Opportunity to Support Local Development Districts Serving Distressed Areas and Marginalized Groups



Application Deadline: Saturday, December 31, 2022

Appalachia's 74 Local Development Districts play a critical role in community and economic growth, often serving as the primary development organizations rural areas. With unprecedented amounts of federal funding available, LDDs need support to help their communities identify, access, and best utilize these financial opportunities. Through READY LDDs, ARC is making a total of \$2 million available to help LDDs increase staffing and capacity to support local governments and nonprofits in the management of American Rescue Plan Act (ARPA), Infrastructure Investment and Jobs Act (IIJA), and other sources.

Virginia AHEC Scholars Program

Application Deadline: ongoing

The Virginia AHEC Scholars Program recruits, trains, and supports a diverse group of students from across the state, creating a multidisciplinary team of health professionals committed to both community service and the transformation of health care in Virginia.

Selected applicants participate in a two-year educational program and may be eligible to receive a stipend. Each AHEC Scholar will receive a Virginia AHEC Scholars Certificate, setting them apart from other students in an increasingly competitive environment. Selected scholars will also have the chance to meet leaders in health care and make connections with other participants, creating an invaluable network for their future careers in health care.
