### Secure and Resilient Commonwealth Panel Charter

- Secretary Public Safety and Homeland Security chairs.
- The Panel shall have as its primary focus emergency management and homeland security within the Commonwealth to ensure that prevention, protection, mitigation, response, and recovery programs, initiatives, and activities, both at the state and local levels, are fully integrated, suitable, and effective in addressing risks from man-made and natural disasters. The Panel shall where necessary review, evaluate, and make recommendations concerning implementation of such initiatives\*. The Panel shall also make such recommendations as it deems necessary to enhance or improve the resiliency of public and private critical infrastructure to mitigate against man-made and natural disasters.




# Health and Human Resources Subpanel


- Only subordinate entity In-place since inception of the Panel

### **OEP Overview**


The Office of Emergency Preparedness (OEP) exercises oversight of and coordinates Emergency Preparedness, Response, and Recovery across VDH to include coordination with all local health districts and healthcare facilities statewide. OEP:

- Facilitates staffing of the VDH Emergency Coordination Center; and, when activated, the Virginia Emergency Operations Center (VEOC) to lead the health and medical response (Emergency Support Function 8).
- Coordinates statewide distribution of emergency medical countermeasures.
- Leads the development, implementation, maintenance and regular exercising of the statewide VDH Emergency Response Plan, ensuring coordination with local, state and federal agencies and private sector partner planning.
- Manages the Centers for Disease Control and Prevention (CDC) Public Health Emergency
  Preparedness (PHEP) Cooperative Agreement, CDC Public Health Crisis Response Cooperative
  Agreement and the U.S. Department of Health and Human Services Hospital Preparedness Program
  (HPP) Cooperative Agreement.





## Medical Reserve Corps (MRC) Program Updates

- Virginia MRC Celebrating 20 years this month
  - First 12 units established in September 2003
- The Statewide Virginia Behavioral Health MRC Unit now officially recognized by the ASPR MRC program.
  - Collaboration with Department of Behavioral Health & Developmental Services
- State-Level MRC Radiological Health Response Team
  - EAC Support Team training on Aug 23
  - Non-Plume Zone (NPZ) Monitoring Team Training on Sep 13
- Collaboration with EVMS: Compassionate Crisis Care Video Series

  - 3rd Video (in development) will be specific to EMS and First Responders



# Continuity of Operations Plan (COOP) Update

- An electronic planning and tracking tool is being developed to support Offices and LHDs with developing and maintaining continuity plans
- VDH requires each Office and LHD to have its own Continuity Plan, which feeds into the overall agency plan
- Goal is to create a standardized, online planning environment, that not only produces a hard copy document but will also serve as a "living plan."
- Timeline for the project will be shared soon; anticipated rollout is early fall
  - Currently collecting Primary and Secondary Coordinators for each work unit. Districts / Offices should have completed survey sent via email on July 17.
- Training, examples and other support will be provided
- Existing plans can still be updated prior to the rollout of the new tool

## Occupational Health & Safety Program Team

### **Accomplishments**

- Completed a full analysis of existing occupational health & safety guidance in place for the VDH workforce.
  - During the initial analysis of the VDH Program there were twenty-three specific regulatory health & safety topics identified as missing policies/procedures or needing some level of updating.
  - Six specific topics were identified as high priority for implementation due to potential exposure levels or regulatory focus.
- Evaluated multiple electronic software packages commercially available for the collection and maintenance of workforce health records.
  - Identified using existing data management capabilities within VDH to utilize for workforce health records. A
    combination of REDCap (for HIPAA PHI/PII information) and Veoci (for general tracking fit test, respirator clearance,
    etc).
- Developed REDCap tool to electronically collect/review the required Respirator Medical Evaluation Questionnaire and provide the Respirator Clearance.
- Facilitated Safety Observations for 30+ LHDs and Offices identifying opportunities for improvement, assisting with corrective and preventive actions.
  - Assisted with follow-up on serious workplace accidents.



## **Occupational Health & Safety Program Team**

- Coordinated efforts with Human Resources on OSHA/VOSH Log (recordkeeping of work-related injuries/illnesses)
  - Assisted with the completion of the OSHA/VOSH 300A Annual Summaries.
  - Reviewed the previous five years of recordable injuries/illnesses to trend and identify hazardous condition.
- Collaborated with Radiological Health on Workplace Radon Project.
- Provided updated training for Respirator Fit Testing both within VDH and to external partners.
- Collaborated with LHDs, upon request, for occupational health & safety presentations for "all hands days".
- Presented, as SME, on multiple EPR Lunch and Learns, along with monthly health & safety bulletins for the Agency Forum.
