

- **Opioid Impact Reduction Registry Report (SB 1415)**
 - Coordination with nonprofit organizations
- **Virginia Prescription Monitoring Program (PMP)**
 - Expanded interstate data sharing
 - Prescriber report cards & clinical alerts
- **Emergency Department Bridge to Treatment Program**
 - Carilion Clinic partnership
 - Peer support & follow-up care
- **Public Health–Public Safety Collaborations**
 - Opioid Rapid Response Program
 - Overdose Fatality Review Team (EO 26)
 - ODMAP expansion

Data Achievements

- **Overdose Needs Assessment Tool**
 - Dashboard launched (2021–2023 data); 2024 update due Feb 2026
- **Updated Dashboards**
 - Overdose deaths, ED visits, neonatal abstinence syndrome
 - Cited in 26+ media articles (Jan–Aug 2025)
- **Wastewater Surveillance**
 - Plan developed for fentanyl detection (EO 26)
 - Pilot program (RFP released Q1 2025) to sample up to three sewersheds

Harm Reduction Expansion

- **Comprehensive Harm Reduction (CHR)**
 - 15 sites statewide
 - 3-site pilot for pregnant women (Opioid Abatement Authority funding)
- **Naloxone & Test Strip Distribution (SFY 2025)**
 - 837 partners (+30%)
 - 158,700 naloxone kits (+10%)
 - 355,390 test strips (+15%)
- **New Products & Tools**
 - Injectable & 8 mg nasal naloxone
 - Nitazine test strips (2025)
 - New naloxone ordering portal
