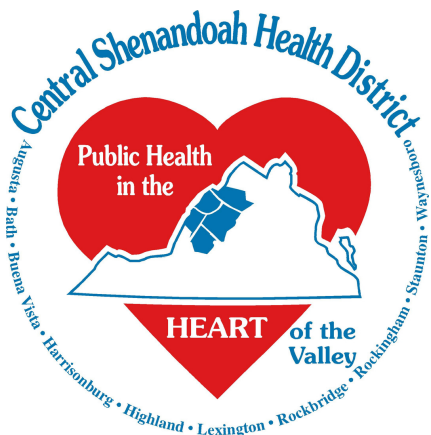

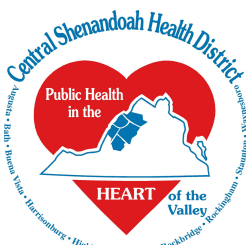

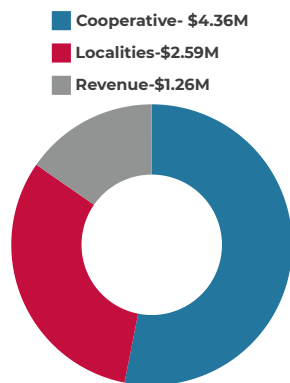

# FISCAL INFORMATION

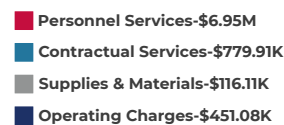
Central Shenandoah Health District receives funding through a variety of sources, including funds from the state, localities, and grants. The 2023 fiscal year runs from June 2022 to July 2023.

## FY 2023 CSHD COOPERATIVE BUDGET



There are three main sources making up the CSHD budget. The cooperative budget consists of Commonwealth general funds, locality funds, and projected revenue. CSHD generates revenue from clinical services, environmental health permitting fees, and vital record requests.

## TOTAL EXPENSES FY 2023



Expenditures consist of personnel services, contractual services, supplies and materials, transfer payments, and continuous charges.

## FEDERAL GRANTS

The health district receives federal grants for different programs. Each grant has specific guidelines as to how the money can be used as well as varying timeframes in which the money can be used.

# VITAL RECORDS

The Vital Records program allows community members to access essential documents. In 2023, over 5,700 requests were made with over 20,000 documents provided to CSHD residents.

This is achieved through nutrition education, breastfeeding promotion and support, supplemental nutritious foods, counseling, and screenings and referrals to other health, welfare, and social services.

Duties include investigating reports of possible exposure to rabies, submitting animal specimens for rabies testing, and following up with both animal and human exposures.

# EMERGENCY PREPAREDNESS & RESPONSE

This program works with local emergency response partners to enhance readiness to respond to all hazards, including bioterrorism, infectious disease outbreaks, and other public health emergencies.

## ACTIVITIES AND HIGHLIGHTS

### **Successful Project Public Health Ready recognition:**

The criteria-based training and recognition program assesses local health department capacity and capability to plan for, respond to, and recover from public health emergencies. The project included significant investment from Emergency Preparedness & Response and other disciplines to prepare and refine submissions for in-state and national review.

### **Flu Vaccination Exercise at James Madison University.**

Over 600 students, faculty, and staff were administered flu shots over three days leveraging staff and volunteers from both CSHD and JMU. Collaboration between CSHD and the University Health Center ensured successful vaccine distribution and provided staff with valuable insights into further refining process and procedure.

### **Further strengthen relationships with community partners.**

Building upon relationships previously established as a result of the COVID-19 public health response, Emergency Preparedness & Response staff attended Local Emergency Planning Committee meetings, engaged in local, regional, and statewide trainings and exercises, and collaborated with non-governmental organizations and coalitions.

### **Yearly reevaluation and revision of emergency plans.**

Thorough assessment of previous exercises and emergency events, integration of evolving standards in emergency management and healthcare, and feedback from staff and community partners informed changes to CSHD's Emergency Operations Plan. This all-hazards plan details the mitigation, preparedness, response, and recovery process for emergencies in and involving the Health District.

### **COVID-19 and Mpox response.**

CSHD further addressed community vaccination needs by transitioning isolated events into in-office clinics, providing reliable access for both children and adults. Newly hired Emergency Preparedness & Response staff assisted in operational changes and enabled other staff to resume necessary responsibilities and tasks of various programs.



# EMERGENCY PREPAREDNESS & RESPONSE

## MEDICAL RESERVE CORPS (MRC)

Central Shenandoah MRC volunteers supported CSHD COVID-19 vaccine clinics until the official end of the federal COVID-19 emergency response on May 11, 2023, with five MRC volunteer vaccinators contributing 95.7 hours of service in 22 deployments over 15 days, at 8 different event locations throughout the beginning of the year. Volunteers also supported various daily public health activities, such as assembling kits for sexual health outreach, supporting back-to-school immunization clinic events and other non-emergency CSHD vaccination clinics held at community events for a total of 36 volunteer hours over 6 separate vaccination events, supporting one walk-in STI-testing clinic, and three REVIVE! Naloxone Education and Opioid Overdose Response training outreach events. During a local and regional emergency preparedness exercise, volunteers participated as either as exercise “players” or “patient actors,” at 4 events in 17 deployments, with 11 unique volunteers contributing a total of 60.5 hours. Additionally, CSMRC volunteers supported a Chart Filing Project for Harrisonburg-Rockingham Health Department throughout June and July of 2023, with 8 volunteers contributing 82.25 hours in 19 deployments over 14 days. This project helped strengthen coordination between the MRC coordinator and CSHD Office Support Services and enabled the Harrisonburg-Rockingham Health Department to serve the public with greater efficiency due to significant improvements in their record storage system.

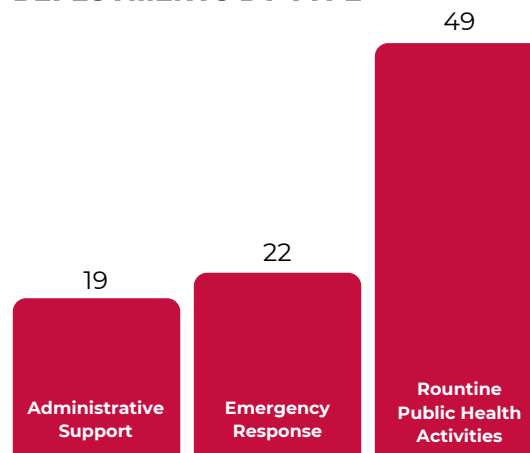

# CLINICAL SERVICES

The Clinical program strives to support health promotion, disease prevention, and community health and wellness across the entire lifespan by offering different clinical services. The Immunization program offers vaccines to adults and children to reduce morbidity and mortality associated with vaccine-preventable diseases. The Newcomer Health program provides screenings and services for newly arrived refugees and other qualified individuals. Services include immunizations, general and mental health screenings, and follow-up referrals. The Sexually Transmitted Infections program strives to prevent the spread of STIs through education, outreach, and providing counseling, testing, treatment, and referral services. Tuberculosis management is also offered through risk assessment screenings and testing. Screenings for long-term care pre-admission are offered.

## NEWCOMER HEALTH

The Newcomer Health program provides screening and services for newly arrived refugees and other qualified individuals. Most clients utilizing this service are within the areas of Harrisonburg City and Rockingham County. Newcomers receive all necessary immunizations, general health and mental health screenings, and follow-up referrals, within 45 days of arrival.



## 26 OFF-SITE CLINICS

CSHD hosted 26 community based clinics in 2023. Immunizations were the focus of these clinics.

## STI TESTING & TREATMENT

The STI program is offered at all locations, but appointments for 2023 were predominantly made at the Harrisonburg City/Rockingham County and Staunton City/Augusta County office locations. Clinics offer counseling, testing, treatment, and partner referral services for patients at risk of or currently experiencing STIs.
