Introduction

The 2024-2028 Charles City County Community Health Improvement Plan (CHIP) Year 1 Annual Report reviews the progress of all strategies and objectives completed or updated during the first year of implementation. All updates were provided by the lead organizations involved in drafting the [2024-2028 Charles City County CHIP](#) report. The CHIP is a long-term systematic effort that focuses on the top three health priorities identified by the community. The priorities were based on the results of the [2023 Charles City County Community Health Assessment](#) (CHA) that included input from residents, nonprofits, faith-based groups, county agencies, healthcare organizations, and business leaders. The three priority areas of the CHIP are: 1) Healthcare Access and Quality; 2) Economic Stability, Infrastructure and Workforce Development; 3) Childhood Health and Education. The CHIP is a living document and can be changed throughout the 5-year plan. This annual report covers the period from July 1, 2024 (report publication date) to June 30, 2025. Evaluating implementation efforts is an important part of sustaining improvements and supporting our community partners as they work to ensure their efforts are leading to the health impacts they intended.

Process for Monitoring and Evaluation

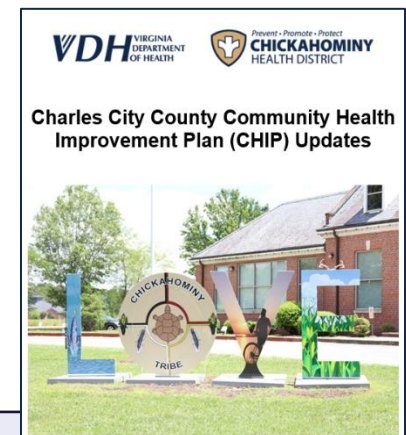

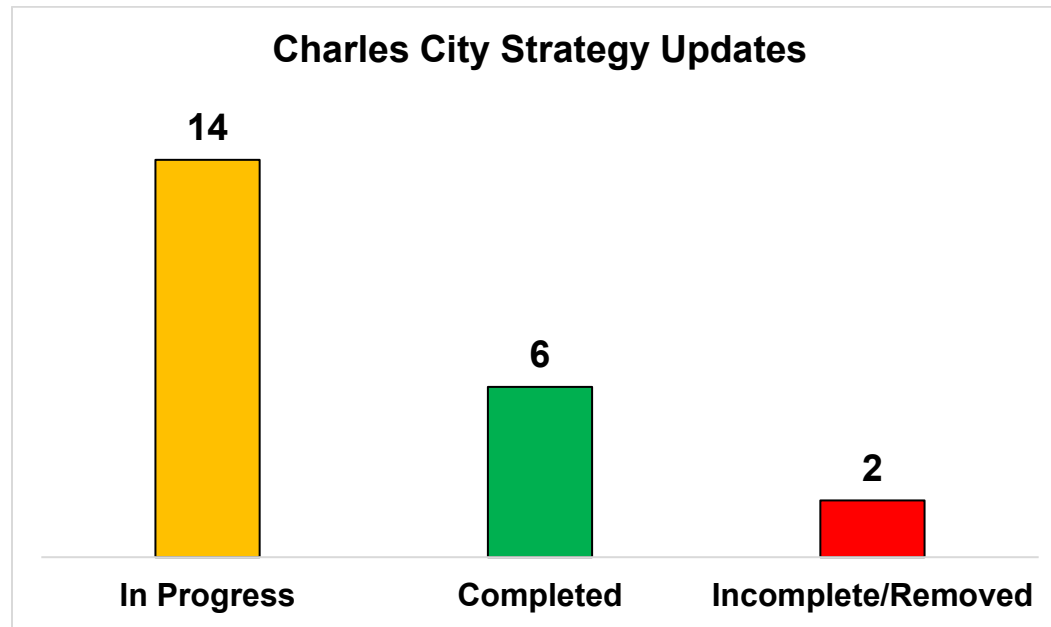

Overall Status of Healthcare Access Strategies

Strategy 1: By March 31, 2025, Charles City County Fire/EMS will determine if they are able to establish a paramedicine program to improve access to preventive services and address the needs of rural residents more efficiently.

➔ **Update: In progress.** The Charles City County Fire/EMS Department has looked into the logistics of running a Community Mobile Medicine program. Leadership went to a conference in September 2024 to learn more about the program. Staffing, funding and capacity will be the biggest barrier to overcome when launching and sustaining this program. No other updates have been provided for Year 1.

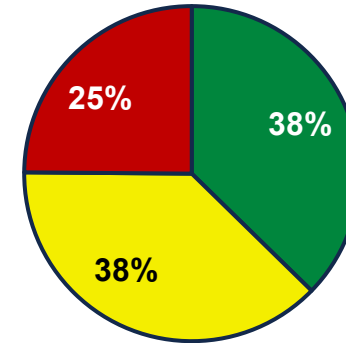
Strategy 2: By March 31, 2025, the Charles City Health Department will be "relaunched" into the community with an Open House, list of services, and updated facility features.

✓ **Update: Complete.** A team was formed to plan the Open House which occurred on October 9th, 2024. Approximately 75 individuals, including children, attended the Open House and the Chickahominy Health District offered flu vaccines (41 vaccines), tours of the newly renovated space, activities for children, and stations showcasing the programs and services available to community members.

Strategy 3: By December 31, 2025, Central Virginia Health Services (CVHS) will conduct an assessment of available school-based dental programs/models to determine the feasibility of implementation within the Charles City Public Schools.

✗ **Update: Incomplete.** No updates have been provided for this strategy in Year 1; therefore, it is considered incomplete for the first year. We will continue to seek updates.

Strategy 4: By June 30, 2028, Charles City County Department of Social Services will host two Community Resource Fairs to offer a variety of preventive services, increase awareness of services available, and coordinate mobile health units at least every other year taking place in Charles City County.



Update: In progress. A Community Resource Fair will be held every other year. There was one held in April 2024, and the next fair will be held in the Spring of 2026. The Charles City Department of Social Services is also tentatively scheduling a Senior Resource Fair for June 2026.

Strategy 5: By June 30, 2025, the Prevention Multidisciplinary Team (MDT) will develop an online directory for the community and partner organizations to use for health-related referrals.



Update: Complete. The Prevention MDT has an online directory on the Charles City County website. It has information on how to access services for physical health, mental health, and overall wellness. The link to the directory is on the county website at <https://www.charlescityva.us/529/Prevention-Multidisciplinary-Team>.

Strategy 6: By June 30, 2025, Charles City County will re-establish a coalition focused on top health issues to improve health across the continuum in Charles City County.



Update: In progress. The Chickahominy Health District, VCU Health, and the acting County Administrator, Mr. Wanner, met in April 2025. The goal of the meeting was to gauge the interest and feasibility of re-establishing the health coalition. A couple roadblocks were experienced during the first two quarters of Year 1. The first roadblock was identifying a lead at the county level to assist with re-establishing the coalition and the second roadblock was the turnover in the position of County Administrator. The previous Administrator was the main contact for this work, so VCU Health connected with the new Administrator, Mr. Bill Coad, to inquire about support for this initiative. Mr. Coad agreed to identify someone from the office by the end of December 2025.

Strategy 7: By September 30, 2024, Chickahominy Health District and CVHS will meet to explore how the Community Health Workers could partner to improve care coordination and address social determinants of health.



Update: Complete. This strategy is considered complete, and they will continue to provide updates. CHD and CVHS met in the early summer of 2024 at the Charles City Library to discuss different roles and how they can

collaborate. For example, CHD's community health staff were coordinating with CVHS to help distribute car seats to a neighboring health district and now that district has established a LISSDEP program.

Strategy 8: By December 31, 2024, Chickahominy Health District will meet with local and regional animal shelters to discuss promoting pet fostering programs/outreach to enhance the social wellness for older adults.

X Update: Removed. CHD staff connected with a successful fostering program, Paws Across Pittsburg, and were working with the New Kent Humane Society to work out the logistics of starting a similar program in Charles City and New Kent counties. However, the primary barrier at this time is the need for a designated point of contact (POC) to help coordinate the Senior Fostering Program. Charles City County has expressed interest in developing a joint Senior Fostering application with New Kent; however, New Kent is currently exploring an independent approach. Efforts have been made to raise awareness of the Fostering Program through the Span Center and the Chickahominy TRIAD by sharing volunteer opportunities and encouraging community involvement. New Kent is continuing to seek a volunteer who can serve as the program's POC and provide support to seniors who are currently fostering or interested in fostering. As of the end of March, marketing efforts for the Fostering Program have not yet begun. This strategy has been removed from the Charles City improvement plan and added to New Kent County's improvement plan.

Overall Status of Economic Stability, Infrastructure, and Workforce Development Strategies

Strategy 1: By June 30, 2028, Charles City County will organize at least one job fair, career expo, and recruitment event in partnership with local employers, including the Charles City County Public Schools, industry associations, and workforce development agencies to showcase job opportunities, conduct on-the-spot interviews, and facilitate job matching and placement for job seekers, at least once a year.

➔ **Update: In progress.** The County met with Career Work on August 5th, 2024, to discuss a regional job fair, which was still in the planning phase. The Economic Development Office partnered with the schools to host a job fair on April 27, 2024. There have not been additional updates.

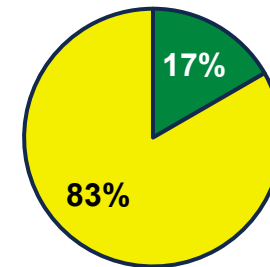
Strategy 2: By September 30, 2024, Charles City County will adopt/approve the Charles City Economic Development and Tourism Strategic Plan.

✓ **Update: Complete.** The strategic plan was adopted May 2, 2024, by the Economic Development Authority. It is posted on the economic development website www.yescharlescityva.com.

Strategy 3: By June 30, 2028, Charles City County will expand broadband infrastructure for rural residents of Charles City County.


➔ **Update: In progress.** CHD is seeking a partner to be the contact for this strategy in order to have regular updates.

 **Update: In progress.** CHD asked a potential community partner if they would be willing to be the contact for this strategy.

Strategy 5: By June 30, 2028, Charles City County will complete an update to the Comprehensive Land Use Plan to prepare for future developments, challenges, and opportunities.

 **Update: In progress.** CHD asked a potential community partner if they would be willing to be the contact for this strategy. The county has established a Citizens Advisory Committee to help develop the new Comprehensive Plan. Strategy 6: By March 31, 2028, at least four new businesses from Charles City County will join the Hopewell/Prince George Chamber of Commerce to receive additional support and resources to grow their locally owned businesses and advance the economic well-being of the community.

 **Update: In progress.** The Economic Development Director was appointed to serve as an ex officio member of the chamber's board beginning January 2025. They will explore opportunities for the chamber to be more present in the community and engage with businesses to encourage them to become members. One of the major roadblocks is communication between the businesses and the Economic Development office. Finding new ways to engage with local businesses is needed.

Priority 2: Economic Stability, Infrastructure, and Workforce Development Achievements and Challenges

Overall Status of Childhood Health and Education Strategies

Strategy 1: By December 31, 2025, Henrico Mental Health and Development Services will facilitate two sessions of the Ending the Silence Youth Suicide Prevention training in Charles City County Schools for school staff, parents and students.

➔ **Update: In progress.** CHD contacted Henrico Mental Health and Developmental Services (HMHDS) for an update and are awaiting their reply.

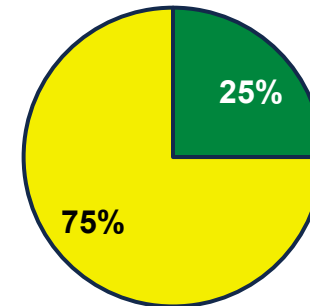
Strategy 2: By June 30, 2025, Henrico Mental Health and Development Services will facilitate two sessions of the Talk Saves Lives training in Charles City County Schools for the school faculty and parents.

➔ **Update: In progress.** HMHDS communicated with the mental health clinician at Charles City Public Schools to schedule a training August 2025.

Strategy 3: By December 31, 2024, Chickahominy Health District will assess the current home visiting programs available to expecting mothers and new parents in Charles City County.

✓ **Update: Complete.** In early 2024, a presentation was created to share current and potential policy (or program) implementation options for home visiting programs in Charles City. The presentation was based on potential models that are established in Virginia that may work well in Charles City. A Community Engagement Specialist was hired by CHD in July 2024 to take over this strategy and a list of home visiting programs for Charles City County has been created.

Status of Childhood Health and Education Strategies, 2025

Strategy 4: By June 30, 2028, Thrive Virginia will ensure that at least 75% of participants in the Healthy Families Home Visiting Program in Charles City County will receive their annual well-child visits.



Update: In progress. Of the 3 reporting periods we received data from THRIVE VA (Quarters 3 and 4 of 2024 and 1 of 2025), at least 75% of participants in the Healthy Families program received their annual well-child visits.

Strategy 5: By December 31, 2024, Chickahominy Health District will meet with Charles City County Fire and Rescue and Charles County Sheriff's Office to explore ways to distribute car seats and/or booster seats to eligible families together.



Update: Complete. CHD staff spoke with Deputy Clinton Robinson from the CC Sheriff's Office about connecting CC County Fire with the appropriate trainers so they could assist with car seat installations. Additionally, CHD met with Sheriff Crawley in May 2025. They hope to schedule car seat events in the future by partnering with other organizations and/or the School Resource Officers.

Strategy 6: By June 30, 2028, Chickahominy Health District will facilitate at least five car seat trainings in Charles City County each year to increase car seat safety.



Update: In progress. For Year 1 of the CHIP, five car seats were installed in Charles City County which met the goal for the year. This strategy will continue to be monitored . The LISSDEP team installed two car seats in Charles City in September and October 2024, two car seats were distributed in Quarter 1 2025, and one car seat in Quarter 2 2025.

Strategy 7: By June 30, 2028, Thrive Virginia will provide 36 Project Discovery workshops (9 each school year) for 9th through 12th grade students at Charles City High School to encourage students to graduate from high school and provide resources to help students achieve post-secondary education success.



Update: In progress. Thrive has provided 9 workshops within Year 1 of the Charles City CHIP, which met the goal for the first year. During Q3 2024, there was 1 Project Discovery workshop at Charles City HS. In Q4 2024, there were 5 workshops which included a cultural enrichment trip and campus tour at the University of Richmond, a financial literacy (Part 1 & 2) and SMART goals workshop, a mindfulness and self-care workshop, and a holiday party. During Q1 2025, the Project Discovery coordinator held 3 workshops, and the topics covered were Healthy

Relationships, the 5 Love Languages activity, painting and honoring diversity, time management, and SMART goals.

Strategy 8: By March 31, 2028, the Charles City County Public Schools will participate in three in-school and/or after-school learning opportunities and/or enrichment programs that partner with community organizations each year for students and their families in Charles City County.



Update: In progress. Charles City Public Schools met with the 4-H representative from New Kent and Charles City, who provided information to support an Economics and Personal Finance activity and a Lego Robotics team at the Elementary School, with planning and coordination still ongoing. Charles City HS partnered with Project BLACC to develop an agriculture club, ordered and assembled a greenhouse with students, and plans to grow and sell flowers in the spring as a first project. The division also planned its May 3 Wellness Fun Fair/Bike Rodeo, which featured a Fun Run, bike activities, wellness sessions, and participation from numerous community partners, and a field trip was planned for the summer school students to the Science Museum of Virginia. In Q2 2025, events included the March “Superhero Night” at Charles City Elementary with NASA representatives, an April mural project with the Indian Parent Committee, and ongoing Project BLACC lessons in agriculture and technical trades.

Priority 3: Childhood Health and Education Achievements and Challenges

THRIVE VA



In the last three reporting periods, 75% of participants in the Healthy Families program received their annual well-child visits.

The Charles City High School is partnering with Project BLACC to develop an agriculture club



The Charles City Public Schools have met with a representative from 4-H for New Kent and Charles City. Information was provided by the 4-H representative to support an Economics and Personal Finance activity and support a Lego Robotics team at the elementary school



A greenhouse has been ordered and delivered and will utilize Project BLACC staff and Charles City High School students to assemble. The goal is to grow and sell flowers in Spring 2025
