Dear Ms. Towey:

In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Pyramid Healthcare, Inc. to establish an intermediate care facility for the treatment and rehabilitation of individuals with substance abuse with 120 beds.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **conditional approval** of the request is warranted based on the following findings:

- 1. The proposed project is generally consistent with the applicable criteria and standards of the State Medical Facilities Plan and the eight Required Considerations of the Code of Virginia.
- 2. A reasonable, less costly, more efficient alternative to the proposed project does not exist.
- 3. The proposed project appears to be economically viable in the immediate and long-term.
- 4. There is no known opposition to the proposed project and the project enjoys broad support from local Community Service Boards and behavioral health organizations.
- 5. The project is not likely to have a significant negative impact upon the utilization, costs, or charges of existing area providers.

- 6. The capital costs associated with the proposed project are reasonable.
- 7. The proposed project will improve access to substance abuse treatment for adult residents of PD 21 and surrounding areas.

This certificate is valid for the period January 13, 2020 through January 12, 2021. The total authorized capital cost of the project is \$4,733,040.

Please file two copies of the application for a certificate extension with the Department no later than 30 days before the expiration date of the certificate.
