Temporarily add 22 ICU Beds at Spotsylvania Regional Medical Center in response to the  
COVID-19 crisis

Dear Mr. McKnight:

In accordance with Executive Order 52, I reviewed the request and all supporting documents submitted by Spotsylvania Medical Center, Inc. d/b/a Spotsylvania Regional Medical Center (SRMC) to temporarily add 22 ICU beds at SRMC. I have considered the factors listed in my March 24, 2020, letter; and I have concluded that **approval** of the request is warranted based on the following findings:

1. SRMC has demonstrated that, due to the reasonable expectation of a sudden and overwhelming increase in acute care patients resulting from COVID-19 infection, SRMC has an immediate need to temporarily add 22 licensed inpatient beds.
2. SRMC's plan for training and shifting ambulatory staff is a reasonable solution for staffing the additional beds.
3. SRMC's plan and ability to obtain equipment and supplies is reasonable within the confines of the current crisis.
4. SRMC's plan to expand bed capacity in existing hospital space throughout the campus assures patient safety is maintained from a fire and life safety code perspective.
