F 000	INITIAL COMMENTS  An unannounced COVID-19 Focused Infection Control Survey was conducted 05/26/2020 through 05/27/2020, and 06/23/2020. The facility was in substantial compliance with 42 CFR Part 483.80 infection control regulations, and had implemented the CMS and Centers for Disease Control (CDC) recommended practices to prepare for COVID-19.  On 05/26/2020, the census in this 60 bed certified facility was 52. There were no COVID-19 positive residents in the facility. Five residents had been tested and results were negative.  On 06/23/2020, the census in this 60 bed certified facility was 51. There were no COVID-19 positive residents in the facility. Six residents and five staff had been tested, all with negative results. The facility has contacted the National Guard who will be conducting testing on all residents and staff 6/25/2020.	F 000
