Dear Ms. Honaker:

In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Carilion New River Valley Medical Center (CNRV) to add three general purpose operating rooms, one of which is to be relocated from Carilion Surgery Center New River Valley, LLC d/b/a New River Valley Surgery Center (NRVSC). The total number of general purpose operating rooms at Carilion New River Valley Medical Center will increase from five to eight. The total number of general purpose operating rooms at Carilion Surgery Center New River Valley, LLC d/b/a New River Valley Surgery Center will decrease from three to two.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **conditional** approval of the request is warranted based on the following findings:

- 1. CNRV's project, as proposed, is consistent with applicable provisions of the SMFP.
- 2. CNRV has demonstrated an institutional need for adding three GPORs at its hospital, with one being relocated from NRVSC.
- 3. No compelling basis for relocating a second GPOR in connection with the project, as recommended by DCOPN in its staff report, exists.
- 4. A public need for CNRV's project, as proposed, exists.
