The facility was in substantial compliance with F-880 of 42 CFR Part 483 Federal Long Term Care requirement(s). On 11/18/2020 the census in this 225 certified bed facility was 172. Of the 172 current residents, 18 residents were currently positive for the COVID-19 virus with no reported hospitalized residents and two reported deaths. The survey sample consisted of five current resident reviews (Resident #1, #2, #3, #4 and #5). One complaint (VA00050049- Substantiated without deficiency) was investigated during the survey.
