The facility was in compliance with E0024 of 42 CFR Part 483.73, Requirements for Long Term Care Facilities.</p> <p>INITIAL COMMENTS</p> <p>An unannounced COVID-19 Focused Infection Control Survey was conducted on 1/25/2021. The facility was in substantial compliance with 42 CFR Part 483.80 infection control regulations, and had implemented the CMS and Centers for Disease Control (CDC) recommended practices to prepare for COVID-19</p> <p>On 1/25/2021, the census in this 89 certified bed facility was 62. The survey sample consisted of five current Resident record reviews.</p> <p>There were 51 positive COVID-19 cases in the facility at the time of the survey. The last facility wide testing was conducted on 1/21/2021, that included 18 residents and 69 staff; 17 residents tested negative, one tested positive; 67 staff tested negative, two tested positive.</p>	F 000
