In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Clinch Valley Medical Center, Inc. to add one computed tomography scanner to be used for simulation with radiation therapy treatment.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **conditional approval** of the request is warranted based on the following findings:

- 1. The proposed project is generally consistent with the applicable standards and criteria of the State Medical Facilities Plan and the Eight Required Considerations of the Code of Virginia.
- 2. The proposed project is more advantageous that the status quo.
- 3. There is no known opposition to the project.
- 4. The capital costs are reasonable for the type of project.
