In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Carilion Medical Center to add one special use magnetic resonance imaging scanner on the Carilion Medical Center campus.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **conditional approval** of the request is warranted based on the following findings:

- 1. The project is generally consistent with the applicable criteria and standards of the State Medical Facilities Plan and the eight Required Considerations of the Code of Virginia.
- 2. The project is more favorable than the alternative of the status quo.
- 3. The proposed project appears economically viable in the immediate and in the long-term.
- 4. There is no known opposition to the project.
