The purpose of this standalone CT scanner is to upgrade the diagnostic CT scans that we have been performing on our hybrid PET/CT scanner for 17 years to a higher slice CT scanner. This will allow for much better diagnostic quality and therefore improved patient care. We do not want to increase our CT referrals. We are merely going to shift our existing diagnostic CT scans from our PET/CT scanner to a better-quality CT scanner. Our volume runs less than 1000 patients per year, and we do not anticipate that this volume will increase significantly.

The scope of this proposed project, located at 3289 Woodburn Road, Suite 90, Annandale, VA, will be relatively small. It will entail upgrading a suite at our location to accommodate the CT scanner. The estimated cost of the scanner is \$360,000.00.
