Dear Ms. Trumbo:

In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Virginia Commonwealth University Health System Authority to add four operating rooms dedicated to pediatric care at VCU Medical Center.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **conditional approval** of the request is warranted based on the following findings:

- 1. The proposed project is generally consistent with the applicable criteria and standards of the State Medical Facilities Plan and the Eight Required Considerations of the Code of Virginia.
- 2. The applicant has demonstrated an institutional need to expand its surgical services.
- 3. The additional operating rooms will be limited to pediatric cases.
- 4. The capital costs are reasonable.
- 5. The proposed project appears economically viable in the long-term.
- 6. The project is more favorable than maintaining the status quo.
